

**My Payment**


My Payment is an electronic payment service offered by the CRA that uses Visa® <sup>1</sup> Debit, Debit MasterCard® <sup>2</sup> or Interac® <sup>3</sup> Online for individuals and businesses to make payments directly to the CRA using their bank access cards. The CRA does not charge a fee for using the My Payment service.

Credit cards are not accepted.

**Note**

BMO is only available through the Debit MasterCard option and no longer through the Interac option on My Payment.


