To Whom This May Concern,

417 has a HUGE problem with corruption.

There's no way to be couth when breaking news like this, so let's just jump right in and see if we can't get this Burton murder solved together.

I'm Abigail Kittrell. I am federally mentally disabled and living in exile in Oregon because I fear threat of Lyle E Peterson. I am unable to live near the family I love, while he continues to threaten them.

I believe my disability has allowed law enforcement to "write me off", as well as the blatant corruption of LE. The crimes of Lyle Peterson have run rampant in Joplin for years! Let's make sure that ends soon, please.

I'm including lots of screenshots so y'all can hear it from their own mouths, since everyone seemed okay to talk about "club business" on Facebook, Facebook Messenger, and through text.

Lyle Eugene Peterson and I have been speaking since September 26, 2023 about him contacting whistleblower attorney John Tye and telling the truth about his corruption of Jasper and Newton Counties. Lyle was diagnosed with cancer that fall and offered me \$3.4 million dollars to move back to Joplin and care for him during his cancer treatment. I did not.

After Lyle sent Lucy Laramée, who he says is a "Hells Angel professional girlfriend", or "club whore", one trusted with club business who rotates from patch member to patch member, I plead my side of our story to HA through her, and because of all the trouble Lyle caused my family, they approved for me to use a civil suit against Lyle and the counties. I was then referred to John Tye through my Oregon attorney, but was "not the correct witness" to bring about the information as witness protection would sever the ties with my children. I then turned to Lyle asking him to share his truth with John Tye for me. Lyle and I have spoken from September 26, 2023 until I divorced him this past Christmas, because he decided to back out of speaking with John Tye.

I told Lyle that the Angels gave me permission to sue, essentially letting him know that his club had betrayed him, therefore he considered telling the truth before he died. The hiccup came when last April Lyle's cancer went into remission. He knew he would get the death

penalty for his crimes, and backed out of speaking with John Tye, because he is going to live.

I am not including my home address or phone number, but anyone who wants the data file I sent out, printed, by USPS, to more than 50 government agencies nationwide, can request a copy by emailing ravennevermore001@gmail.com.

Let's bring this man to justice and get that Burton mother the answers she SO deserves!

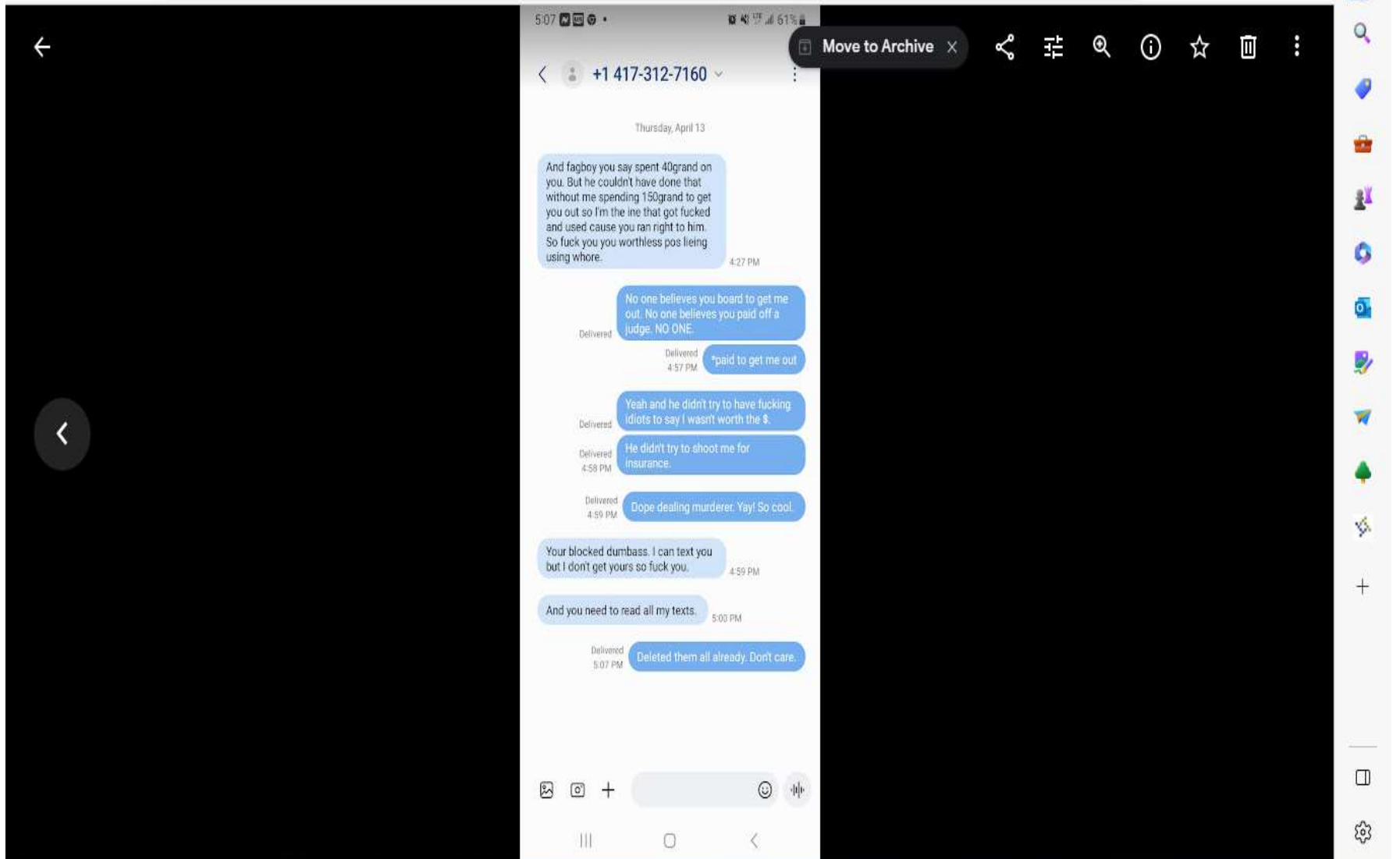
MONGO is Lyle's Hells Angel name.

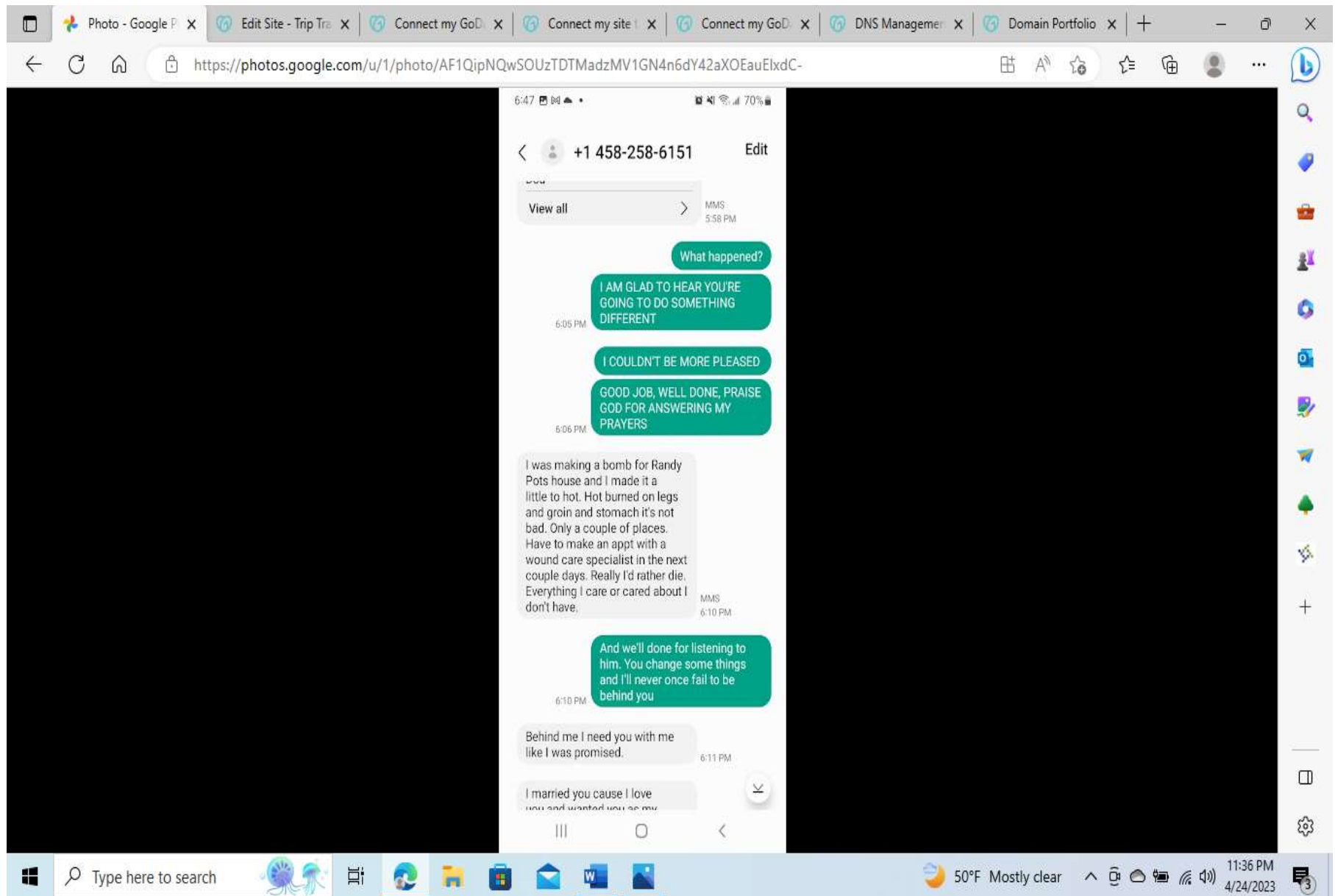
"Mort Swenson" is Lyle's "killer persona" for when he tortures people.

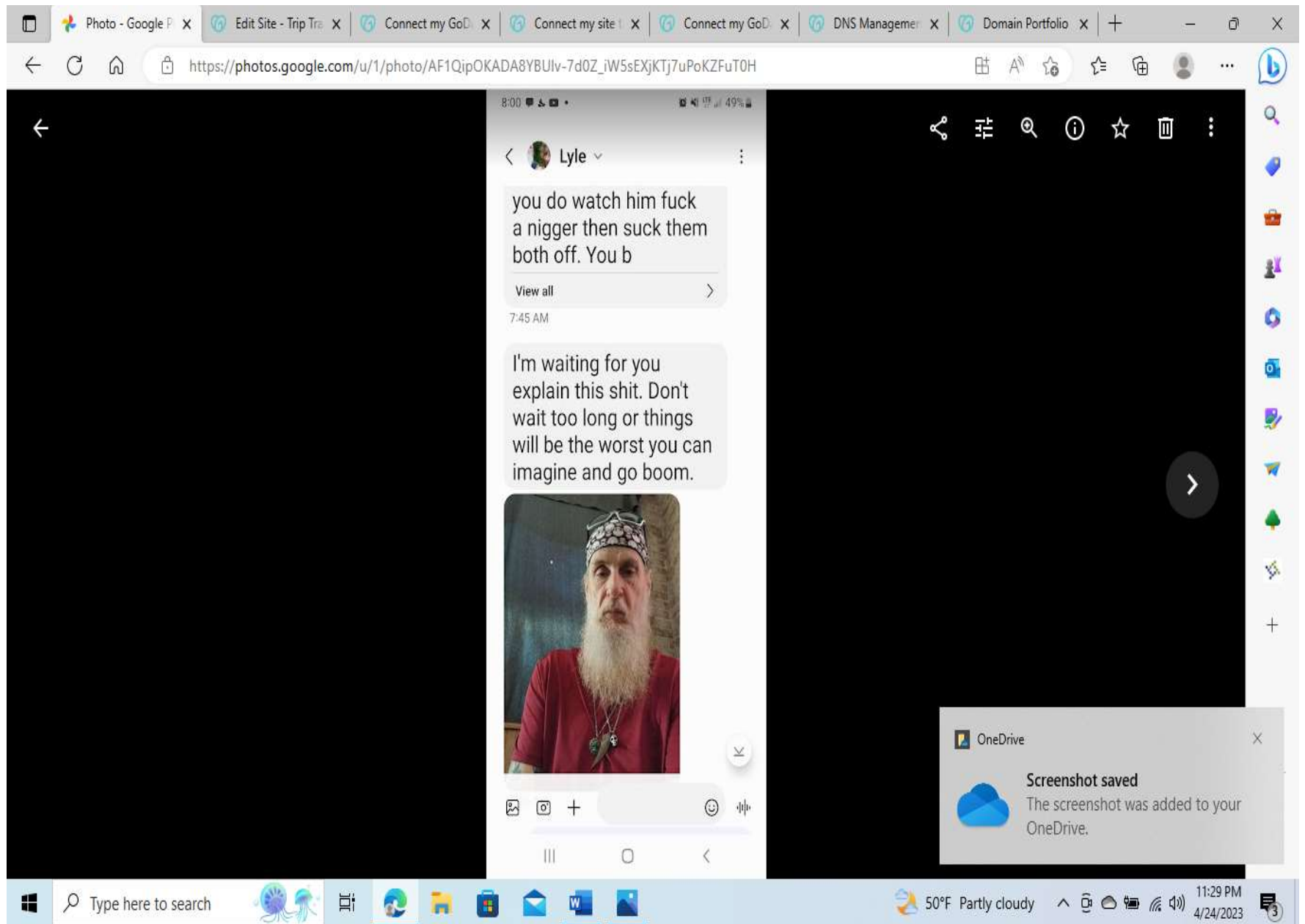


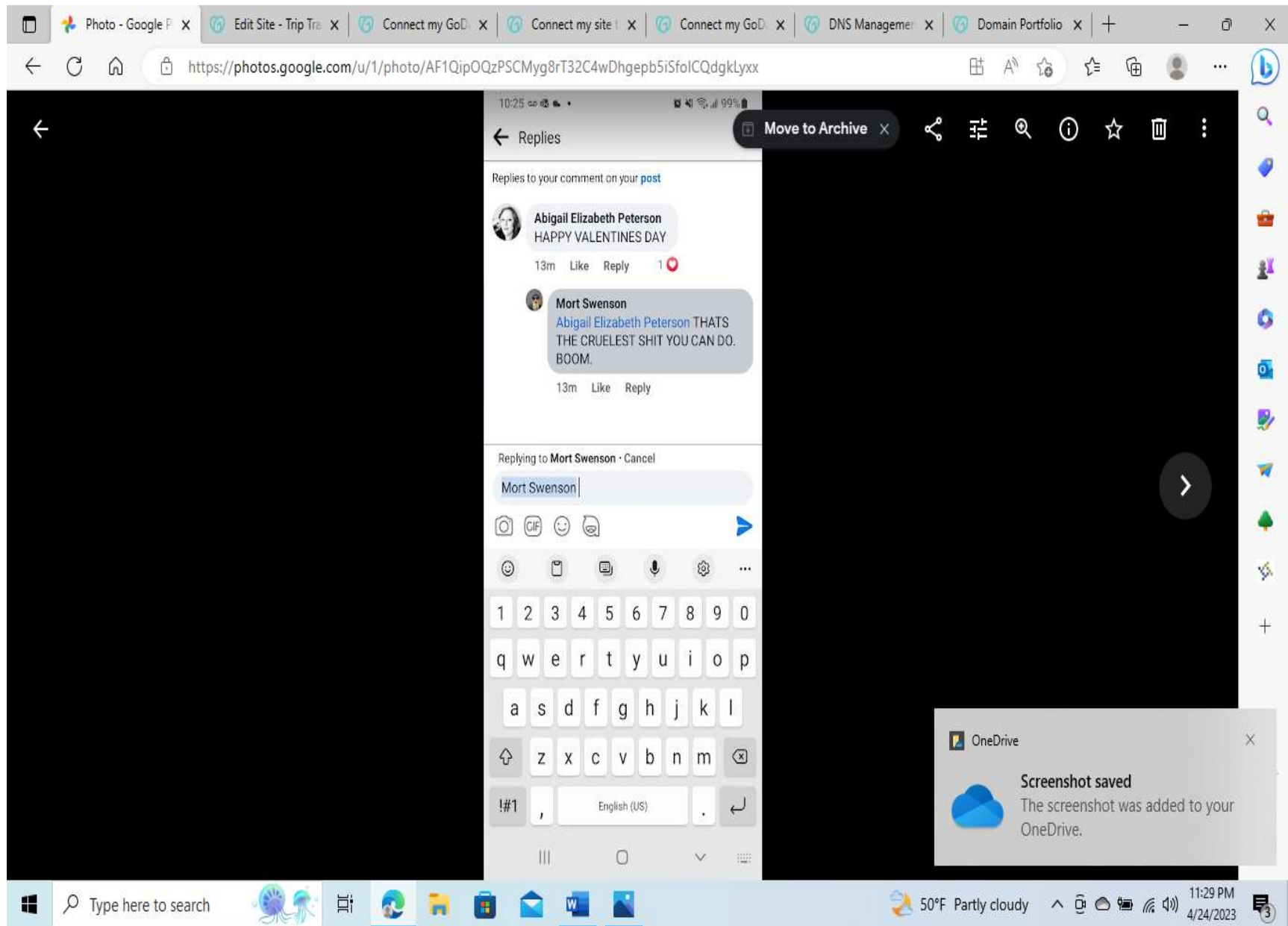


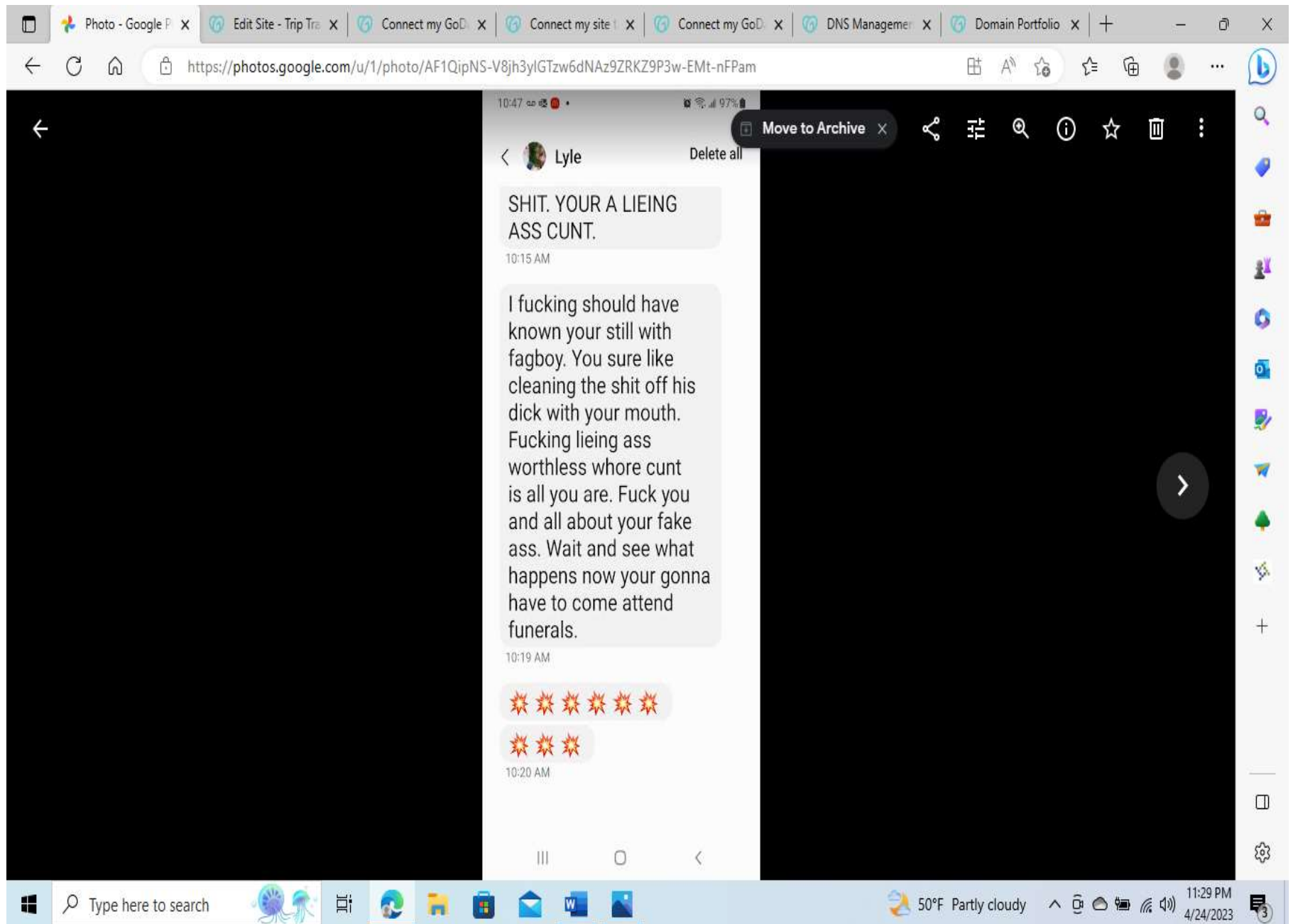

This is Lucy Laramie. Lyle tells me she is a “professional girlfriend”, or “club whore”, trusted to carry out certain tasks for the club. Lyle says she is associated with the Oakland Chapter. He sent her “after” me in Oregon. I was able to plead my case with the Angels through Lucy, through whom the Angels also agreed I could enact a civil suit over my troubles with Lyle and the counties/corruption. Lucy “checked” in on me for two years, telling me many things she SHOULDN’T have. Here are a small portion of those screen shots.

One particular shows that Lyle apparently brags to women, as he also did to me, that he’s “fed lots of people to his woodchipper”.

There is a conversation shown also where Lyle, after finding out he is in remission from cancer, threw a huge BBQ in Kansas, and fed everyone PORK CHOPS. (Lyle feeds the bodies through a woodchipper, to hogs.)

P.S. I wouldn’t eat any more of his BBQ! (he thinks this is a funny joke, by the way.) He called his BBQ “Meat & Greet BBQ”. Everyone was to wear red, because of the Hells Angels.

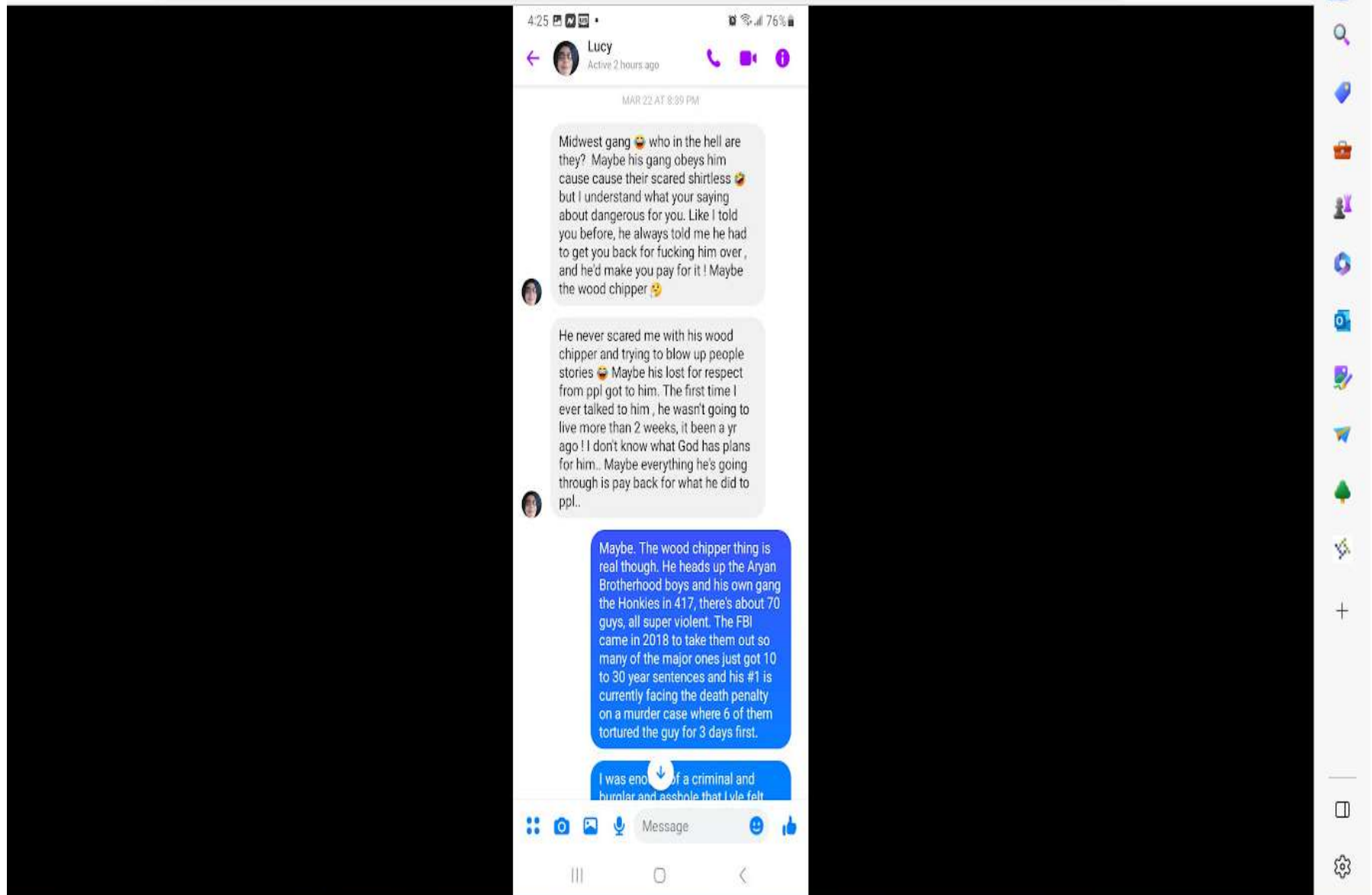

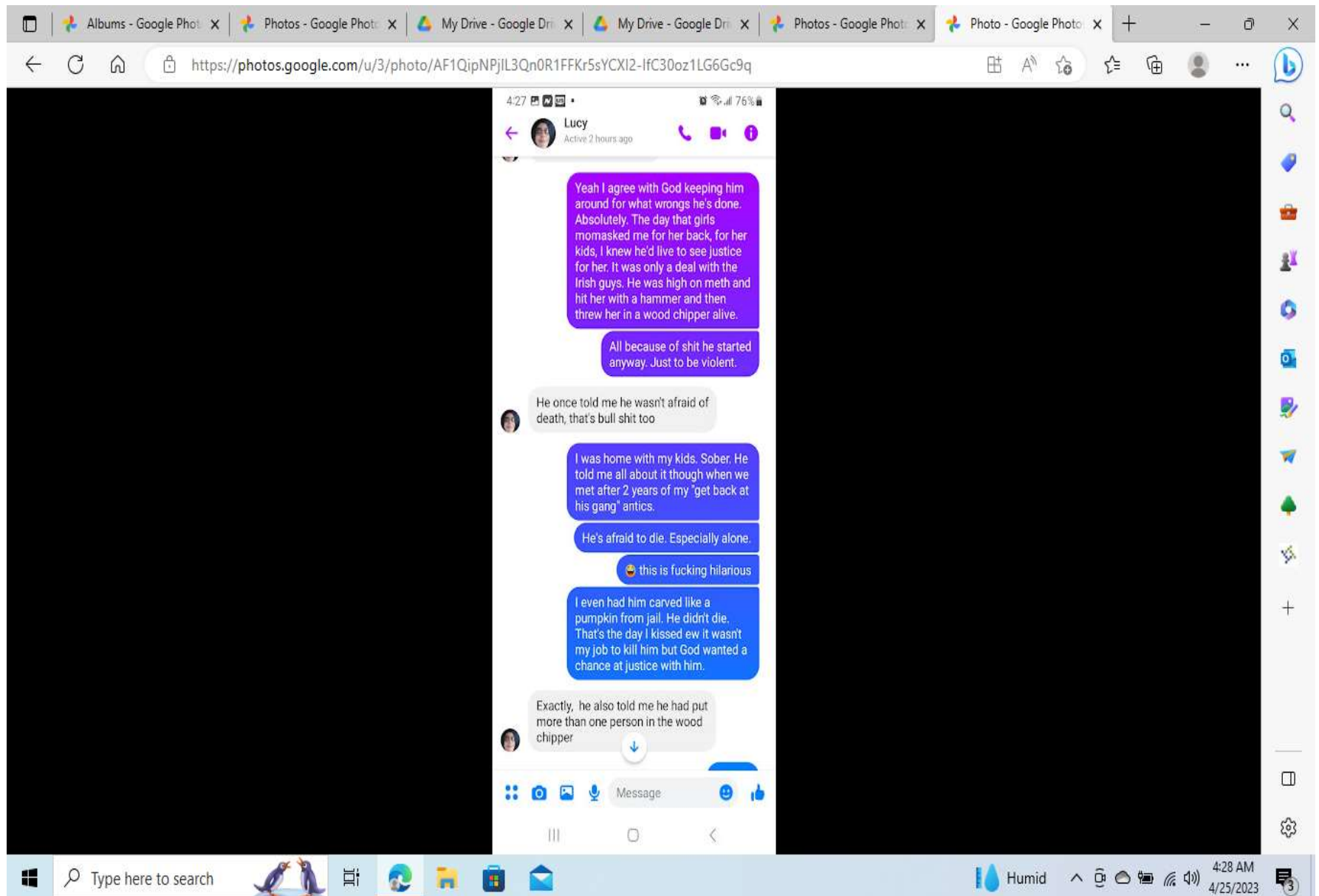

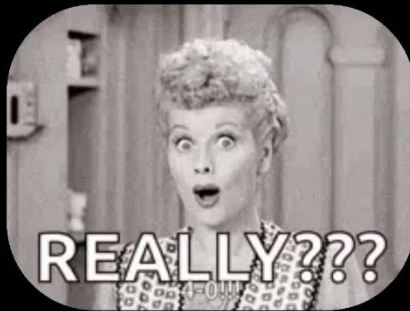
