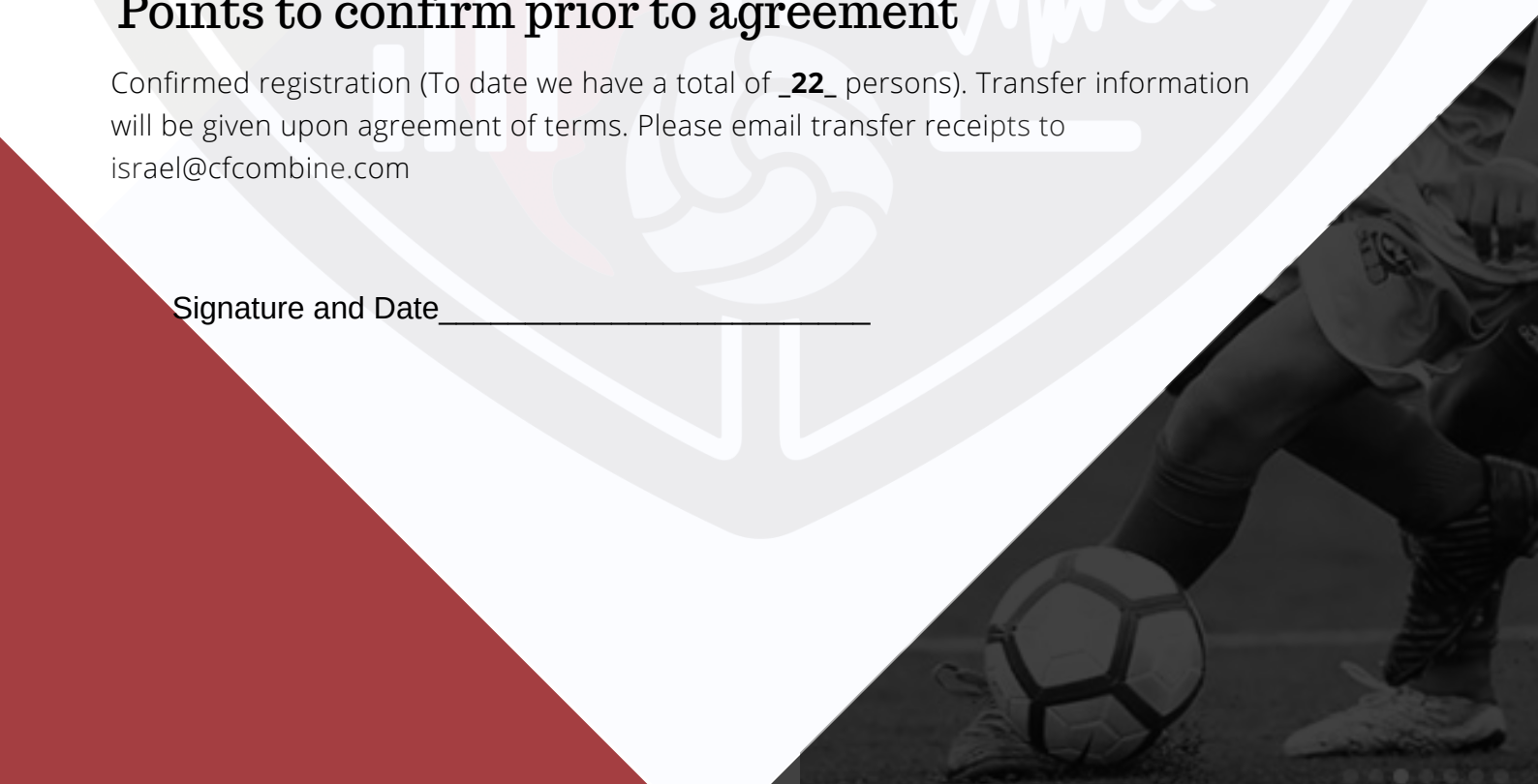

Marketing/Promoting Soccer Training Opportunities. The Player will use its best efforts to promote and market each Camp, and may, but shall not be obligated to, include information about each Camp in the Player's regular newsletters and mailings, or on the Player's website, or by providing information at the Player's regularly scheduled events, including player registration. Player shall produce and supply the brochures and other marketing material, which shall be approved by our organization (if needed), about the Camp in sufficient quantities for each registered player in the region. We will provide the Player with other Camp promotional materials, which shall be approved by the Player, to assist the region with camp promotions and registrations as the Player deems appropriate.

Inclement Weather. In the event that any Session of any Camp must be cancelled due to human scheduling errors, the Provider and our representatives agree to use reasonable efforts to re-schedule such cancelled Session. If such Session cannot be re-scheduled, then we shall refund, on a pro-rata basis, if any fees paid by a camper for specific Session. In the event that any Session of any Camp must be curtailed due to weather on any given day of Camp, we shall use our reasonable best efforts to re-schedule such portion of the curtailed Session, but shall not be required to refund any amounts for Sessions abbreviated due to weather.

10. Refrain from the use of alcohol and narcotics as they are strictly forbidden.
11. Be conscious of any messages (including texts, videos, images, etc.) that I send out on social media. Messages should be positive and uphold the integrity of CFC and affiliates. I will respect others, if they do not wish to have their image/name shared on social media.

Indemnity; Hold Harmless. Player agrees to indemnify and hold harmless our partners, and its agents, representatives, employees, volunteers and players ("CFC, FootVia, EDUsoccer Madrid and other Indemnified Parties") as well as its or their directors, officers, staff, employees, agents and other representatives ("Other Indemnified Parties") from any and all damages, claims, and expenses arising out of or resulting from the operation of any Camp pursuant to this Agreement, including without limitation the use of the fields and facilities during the camp and the acts or omissions of any of our Trainers or other personnel providing services under this Agreement. The Player, through its undersigned representative, and on behalf of its heirs, executors, administrators, related entities, assigns and personal representatives, hereby agrees to release and hold harmless any of our Partners, affiliates, any Indemnified Parties and any Other Indemnified Parties from any damages, claims and expenses related to any fields, facilities or equipment provided in connection with this Agreement or for the failure to obtain any such fields, facilities or equipment.

Insurance. Footvia will provide player insurance. Players must also provide proof of medical and accidental insurance before attending the tournament activities, and the Region shall use its best efforts to assist the Provider in securing those waivers. Players must also carry their own insurance prior to arrival Term; Termination. This Agreement shall terminate six months from the date of this Agreement. Fees will be returned minus those associated with booking and non-refundables.

Independent Relationship. Contents herein or in any other document executed in connection herewith, shall be construed to create a joint venture relationship between the party noted below or/and event personnel.

General.

- a. This Agreement shall be governed by and construed under the laws of the State of which it represents. The parties agree to submit to the jurisdiction of the state and federal courts located in the state in which the proposed camp is to be held.
- b. Neither the invalidity nor unenforceability of any provision of this Agreement shall affect the validity or enforceability of any other provision. Failure to invoke any right, condition or covenant of this Agreement by either party shall not be deemed to imply or constitute a waiver of any right, condition, or covenant and neither party may rely on such failure.
- c. This agreement constitutes the entire agreement and understanding between the parties with respect to the subject matter hereof, constitutes a valid and binding obligation of the parties hereto as well as their successors and assigns enforceable in accordance with its terms and may not be assigned in whole or in part by event personnel without the prior written consent of the Player.
