VILLAGE OF HOSSTON MINUTES OF THE REGULAR COUNCIL MEETING HELD SEPTEMBER 17, 2024

The Mayor and Board of Aldermen of the Village of Hosston met in regular session Tuesday, September 17, 2024, at 6:30 pm, in the Village Hall, Hosston, LA.

Present: Mayor Kim Jaynes, Alderman Misti Banks, Alderman Henry Blunt, Alderman Vicki Carter, and Chief Ramona Anders.

Mayor Jaynes called the meeting to order at 6:30 pm, at which time a quorum was verified. Opening prayer was led by Alderman Banks and all present joined in the Pledge of Allegiance.

There were no public comments on agenda items.

Chief Anders reported that she completed another class where she received useful information and resources that would be beneficial. She also reported that she has still been patrolling regularly and had addressed some issues concerning trash in resident's yards.

Mayor Jaynes informed the board that the name of the new walking path and pavilion would be Village of Hosston Memorial Park. Mayor Jaynes announced that a rummage sale will take place on October 12th at the pavilion for anyone who had items to donate.
