VILLAGE OF HOSSTON MINUTES OF THE REGULAR COUNCIL MEETING HELD DECEMBER 17, 2024

The Mayor and Board of Aldermen of the Village of Hosston met in regular session Tuesday, December 17, 2024, at 6:30 pm, in the Village Hall, Hosston, LA.

Mayor Jaynes called the meeting to order at 6:30 pm, at which time a quorum was verified. Opening prayer was led by Alderman Banks and all present joined in the Pledge of Allegiance.

Alderman Carter made a motion to introduce **Ordinance No. 8 of 2024** TITLE: AN ORDINANCE FOR THE CODE OF ORDINANCES, VILLAGE OF HOSSTON, TO REVOKE AND SET ASIDE A PORTION OF A ROAD LOCATED WITHIN THE TOWN LIMITS OF THE VILLAGE OF HOSSTON, CADDO PARISH, LOUISIANA, seconded by Alderman Blunt. All in favor motion carried.

Chief Anders presented the board with an itemized summary of her medical bills and mileage for her personal expenditures that she had incurred after being hurt on the job. The summary included a blank space for the anesthesiology bill because she did not have a final amount on it. When Chief Anders was hurt, the town did not realize that their elected officials were not covered by workman's compensation. Since her accident, coverage has been applied. Mayor Jaynes reminded the board that in 2021 it was decided that no reimbursement would be given to Chief Anders for her accident because she would not sign a release. Chief Anders stated that she would now sign a release. Mayor Jaynes also informed the board that the Village of Hosston is not required by law to have workman's compensation on elected officials.
