## VILLAGE OF HOSSTON MINUTES OF THE REGULAR COUNCIL MEETING HELD APRIL 21, 2022

The Mayor and Board of Aldermen of the Village of Hosston met in regular session Thursday, April 21, 2022, at 6:30 p.m., in the Village Hall, Hosston, LA.

Present: Mayor Kim Jaynes, Alderman Misti Banks, Alderman Henry Blunt, Alderman Tiffany Payton, Chief of Police Ramona Anders, Town Clerk Amanda Anglin

Mayor Jaynes called the meeting to order at 6:30 p.m., at which time a quorum was verified. Opening prayer was led by Chief Anders and all present joined in the Pledge of Allegiance.

Alderman Blunt made a motion to approve the agenda, second by Alderman Banks. All in favor, no opposed, motion carried.

The next item on the agenda was public comments on agenda items: There were none.

Chief Anders opened discussion regarding lowering the speed limit on Rosedale and passing an ordinance prohibiting grass clippings on roadways.

Mayor Jaynes told the Board we had a great turnout for the Easter egg hunt. Hosston will be having a clean-up day on April 23<sup>rd</sup>, in conjunction with Love the Boot Week. A 6" water line is being installed down Parkway. The line will eventually loop back around to Hwy 71. Bank draft payments will be starting soon.

Alderman Payton made a motion to approve the March 2022 meeting minutes, seconded by Alderman Blunt. All in favor, no opposed, motion carried.

Alderman Banks made a motion to approve the March 2022 financial statements, second by Alderman Payton. All in favor, no opposed, motion carried.

Alderman Banks made a motion to approve made a motion to approve Resolution No. 2 of 2022 Title:

A RESOLUTION PROVIDING FOR CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE SPECIAL ELECTION HELD IN THE VILLAGE OF HOSSTON, STATE OF LOUISIANA, ON SATURDAY, MARCH 26, 2022, TO AUTHORIZE THE SALE OF ALCOHOLIC BEVERAGES THEREIN, second by Alderman Blunt. All in favor, no opposed, motion carried.

Alderman Blunt made a motion to introduce Ordinance No. 2 of 2022 Title: AN ORDINANCE TO ADOPT RULES AND REGULATIONS UNDER CHAPTER 7, TO PROVIDE FOR ALCOHOL BEVERAGE CONTROL; AND PROVIDING PENALTIES FOR VIOLATION OF SAME, second by Alderman Payton. All in favor, no opposed, motion carried.

Mayor Jaynes presented a proposal from Pat Doane regarding annexation of the property the truck stop will be built on. The annexation will cost between \$5,000-\$8,000. Alderman Banks made a motion to approve hiring Pat Doane to do the annexation, second by Alderman Payton. All in favor, no opposed, motion carried.

Public comments were called for. There were none.

Alderman Blunt made a motion to adjourn at 7:01 p.m., seconded by Alderman Banks. All in favor, no opposed, motion carried.
