VILLAGE OF HOSSTON MINUTES OF THE REGULAR COUNCIL MEETING HELD NOVEMBER 15, 2022

The Mayor and Board of Aldermen of the Village of Hosston met in regular session Tuesday,

November 15, 2022, at 6:30 p.m., in the Village Hall, Hosston, LA.

Mayor Jaynes called the meeting to order at 6:30 p.m., at which time a quorum was verified. Opening prayer was led by Chief Anders and all present joined in the Pledge of Allegiance.

Alderman Blunt made a motion to approve the agenda, second by Alderman Payton. All in favor, no opposed, motion carried.

There were no public comments on agenda items.

Chief Anders had nothing to report.

Mayor Jaynes said the October fest turned out well. We will be having pictures with Santa on December 10th, 1 p.m.-3 p.m. Saturday, December 17th will be another Hosston clean-up day.

Alderman Payton made a motion to approve the October 2022 meeting minutes, seconded by Alderman Blunt. All in favor, no opposed, motion carried.

Alderman Payton made a motion to approve the October 2022 financial statements, second by Alderman Blunt. All in favor, no opposed, motion carried.

Mayor Jaynes read her Budget Message to the Board. Alderman Payton made a motion to introduce Ordinance No. 3 of 2022 Title: AN ORDINANCE ADOPTING THE BUDGET FOR THE VILLAGE OF HOSSTON, PARISH OF CADDO, STATE OF LOUISIANA, FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2023, AND ENDING DECEMBER 31, 2023, second by Alderman Blunt. 28, 2022, until December 19, 2022. A public hearing will be held on Tuesday, December 20, 2022, at 6:30 p.m.

Alderman Blunt made a motion to amend Ordinance No. 6 of 2021 Title: AN ORDINANCE ADOPTING THE BUDGET FOR THE VILLAGE OF HOSSTON, PARISH OF CADDO, STATE OF LOUISIANA, FOR THE CALENDAR YEAR BEGINNING JANUARY 1, 2022, AND ENDING DECEMBER 31, 2022, second by Alderman Payton. All in favor, no opposed, motion carried. A public hearing will be held on Tuesday, December 20, 2022, at 6:30 p.m.

Alderman Payton made a motion to approve Resolution No. 15 of 2022 Title: RESIDENTIAL ANTIDISPLACEMENT AND RELOCATION ASSISTANCE PLAN UNDER SECTION 104(d) OF THE HOUSING AND COMMUNITY DEVELOPMENT ACT OF 1974, AS AMENDED, second by Alderman Blunt. All in favor, no opposed, motion carried.

Public comments were called for. Alderman Blunt asked if calls had been made about replacing a culvert on Parkway and cutting a dead tree on his property where the Hosston welcome sign is located. There were also questions as to why the water on the sign is black, which it meant to represent Black Bayou. Mayor Jaynes replied that she would be calling about the tree and Chief Anders had called regarding the culvert.
