VILLAGE OF HOSSTON MINUTES OF THE REGULAR COUNCIL MEETING HELD MAY 16, 2023

The Mayor and Board of Aldermen of the Village of Hosston met in regular session Tuesday, May 16, 2023, at 6:30 p.m., in the Village Hall, Hosston, LA.

Mayor Jaynes called the meeting to order at 6:30 p.m., at which time a quorum was verified. Opening prayer was led by Alderman Banks and all present joined in the Pledge of Allegiance.

Mayor Jaynes opened a public hearing for Ordinance No. 2 of 2023 Title: ORDINANCE ANNEXING APPROXIMATELY 8.5 ACRES OF LAND INTO THE CORPORATE LIMITS OF THE VILLAGE OF HOSSTON, CADDO PARISH, LOUISIANA. No public comments or questions on the ordinance. Mayor Jaynes closed the hearing.

Alderman Blunt made a motion to approve the agenda, second by Alderman Pappan. All in favor, no opposed, motion carried.

Mayor Jaynes reported that issues at the library led to having the septic tank cleaned out, so she had the tank at town hall checked. It was full as well and had to be emptied.
