VILLAGE OF HOSSTON MINUTES OF THE REGULAR COUNCIL MEETING HELD OCTOBER 17, 2023

The Mayor and Board of Aldermen of the Village of Hosston met in regular session Tuesday, October 17, 2023, at 6:30 p.m., in the Village Hall, Hosston, LA.

Present: Mayor Kim Jaynes, Alderman Misti Banks, Alderman Henry Blunt, Alderman Vicki Carter

Absent: Police Chief Ramona Anders

Mayor Jaynes called the meeting to order at 6:30 p.m., at which time a quorum was verified. Opening prayer was led by Alderman Carter and all present joined in the Pledge of Allegiance.

Mayor Jaynes opened a public hearing for Ordinance No. 2 of 2008 Title: AN ORDINANCE COMPENSATION THE MAYOR'S SALARY. No public comments or questions on the ordinance. Mayor Jaynes closed the hearing.

Alderman Banks made a motion to approve the agenda, second by Alderman Blunt. All in favor, no opposed, motion carried.

There were no public comments on agenda items.

Alderman Banks asked about the progress of the Truck Stop.

Alderman Carter made a motion to approve waving the reading of the September 19, 2023, regular session meeting minutes, seconded by Alderman Blunt. All in favor, no opposed, motion carried.

Mayor Jaynes presented Introduce: Amend Ordinance No. 1 2021 Title: AN ORDINANCE TO APPOINT AND FIX THE SALARY FOR THE TOWN CLERK OF THE VILLAGE OF HOSSTON. Alderman Carter made a motion to approve, second by Alderman Banks. All in favor, no opposed,

motion carried.

A discussion was had to vote to add Hayden Linn to all financials and bank accounts. Motion to add Hayden Linn was made by Alderman Carter, second by Alderman Blunt. All in favor, no opposed, motion carried.

Public comments were called for. There were none.
