VILLAGE OF HOSSTON MINUTES OF THE REGULAR COUNCIL MEETING HELD JUNE 18, 2024

The Mayor and Board of Aldermen of the Village of Hosston met in regular session Tuesday, June 18, 2024, at 6:30 pm, in the Village Hall, Hosston, LA.

Present: Mayor Kim Jaynes, Alderman Misti Banks, Alderman Henry Blunt, and Alderman Vicki Carter.
Absent: Chief Ramona Anders.

Also Present: Lee Ann Blunt and Bricen Prentice.

Mayor Jaynes called the meeting to order at 6:30 pm, at which time a quorum was verified. Opening prayer was led by Alderman Banks and all present joined in the Pledge of Allegiance.

Alderman Blunt made a motion to approve the agenda, seconded by Alderman Carter. All in favor, motion carried.

There were no public comments on agenda items.

Mayor Jaynes informed the board that she applied for a beautification grant to complement the new walking path project. She also reported that the damage done to the culvert at the library had been fixed and that she is waiting on a quote that will provide restrictions to keep large trucks from accessing the road where the culvert is.

Alderman Carter made a motion to approve the minutes of the regular session meeting on May 21, 2024, seconded by Alderman Banks. All in favor, motion carried.

Alderman Banks made a motion to approve the financials for May 2024, seconded by Alderman Blunt. All in favor, motion carried.

Alderman Carter made a motion to introduce **Ordinance No. 5 of 2024** Title: AN ORDINANCE OF THE CODE OF ORDINANCE, VILLAGE OF HOSSTON, LOUISIANA, TO AMEND AND SUPPLEMENT THE CODE OF ORDINANCES OF THE VILLAGE OF HOSSTON TO ADOPT AN ORDINANCE TO RESTRICT LIVESTOCK WITHIN THE CORPORATE LIMITS, AND TO OTHERWISE PROVIDE WITH RESPECT THERETO, seconded by Alderman Blunt. All in favor, motion carried. *There will be a public hearing prior to the adoption of Ordinance No. 5 of 2024 at the Regular Town Council Meeting at 6:30 pm on Tuesday, July 23, 2024, at the Hosston Village Hall, located at 15669 Hwy 71 Hosston, La.*

There were no public comments.

Alderman Carter made a motion to adjourn at 6:48p.m., seconded by Alderman Blunt. All in favor, motion carried.
