VILLAGE OF HOSSTON ORDINANCE NO. 8 of 2024

AN ORDINANCE FOR THE CODE OF ORDINANCES, VILLAGE OF HOSSTON, TO REVOKE AND SET ASIDE A PORTION OF A ROAD LOCATED WITHIN THE TOWN LIMITS OF THE VILLAGE OF HOSSTON, CADDO PARISH, LOUISIANA

WHEREAS, the Board of Aldermen for the Village of Hosston received a Land Owner's Petition requesting the revocation of an alley located in Block 18, Village of Hosston.

THEREFORE BE IT ORDAINED, by the Board of Alderman of the Village of Hosston that the following described alley, described as follows, to wit:

BEGINNING AT THE SOUTHWEST CORNER OF LOT 1, BLOCK 18, HOSSTON, CADDO PARISH LOUISIANA FOR POINT OF BEGINNING; THENCE RUN SOUTH PARALLEL WITH STATE HIGHWAY APPROXIMATELY 20 FEET TO THE POINT THAT INTERSECTS WITH THE NORTHWEST CORNER OF LOT 12, BLOCK 18, HOSSTON, CADDO PARISH LOUISIANA; THENCE RUN EAST TO THE NORTHEAST CORNER OF LOT 7 BLOCK 18, HOSSTON CADDO PARISH LOUISIANA, THENCE RUN NORTH 20 FEET PARALLEL WITH 5TH STREET TO THE SOUTHEAST CORNER OF LOT 6, BLOCK 18, HOSSTON, CADDO PARISH, LOUISIANA THEN RUN WEST APPROXIMATELY 300 FEET PARALLEL WITH GRAND AVENUE TO THE POINT OF BEGINNING WHICH IS THE SOUTHWEST CORNER OF LOT 1 BLOCK 18, SAID PROPERTY BE MORE FULLY SHOWN IN MARK ON THE ATTACHED MAP AS EXHIBIT A.

is no longer needed for a public purpose and is hereby revoked and set aside.

BE IT FURTHER ORDAINED, that the Village of Hosston reserves unto itself all of the oil, gas and other minerals in, under and that may be produced from the property revoked herein together with all rights of ingress and egress associated with the reservation of said right.

BE IT FURTHER ORDAINED that the Village of Hosston reserves unto itself all of the utilities rights of way and easements that exist in and to said property being revoked herein together with all rights of ingress and egress associated with the reservation of said right.

After public hearings were held on the above ordinance, the title having been read and the ordinance or motion by Alderman seconded by Alderman to adopt the ordinance, a record vote was taken and the following result was:
