RESOLUTION NO. 2 OF 2022

A resolution providing for canvassing the returns and declaring the results of the special election held in the Village of Hosston, State of Louisiana, on Saturday, March 26, 2022, to authorize the sale of alcoholic beverages therein.

BE IT RESOLVED by the Mayor and Board of Aldermen of the Village of Hosston, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Village of Hosston, State of Louisiana (the "Village"), that:

SECTION 1. Canvass. This Governing Authority does now proceed in open and public session to examine the official tabulations of votes cast at the special election held in the Village of Hosston, State of Louisiana, on SATURDAY, MARCH 26, 2022 (the "Election"), to authorize the sale of alcoholic beverages therein pursuant to the following propositions (the "Propositions"):

PROPOSITION NO. 1

Shall the sale of beverages of alcoholic content containing not more than six percent alcohol by volume be permitted by package only and not for consumption on the premises in the Village of Hosston, Parish of Caddo, State of Louisiana?

PROPOSITION NO. 2

Shall the sale of beverages of alcoholic content containing not more than six percent alcohol by volume for consumption on the premises be permitted in the Village of Hosston, Parish of Caddo, State of Louisiana?

PROPOSITION NO. 3

Shall the sale of beverage alcohol containing one-half of one percent alcohol by volume and above for consumption on the premises be permitted in the Village of Hosston, Parish of Caddo, State of Louisiana?

PROPOSITION NO. 4

Shall the sale of beverages of alcoholic content containing one-half of one percent alcohol by volume and above by the package only and not for consumption on the premises be permitted in the Village of Hosston, Parish of Caddo, State of Louisiana?

PROPOSITION NO. 5

Shall the sale of beverages of high and low alcoholic content be permitted only on the premises of restaurant establishments which have been issued an "R" permit as defined by law in the Village of Hosston, Parish of Caddo, State of Louisiana?

This Governing Authority does further proceed to examine and canvass the returns of the Election thereof.

SECTION 2. Election Results. According to the official certified tabulation of votes cast at said Election, there was a total of 58 votes cast IN FAVOR OF Proposition 1 and a total of 30 votes cast AGAINST the Proposition, resulting in a majority of 28 votes cast IN FAVOR OF Proposition 1. The Proposition was therefore duly CARRIED by a majority of the votes cast by the qualified electors voting at the Election. There was a total of 55 votes cast IN FAVOR OF Proposition 2 and a total of 33 votes cast AGAINST the Proposition, resulting in a majority of 22 votes cast IN FAVOR OF Proposition 2. The Proposition was therefore duly CARRIED by a majority of the votes cast by the qualified electors voting at the Election. There was a total of 55 votes cast IN FAVOR OF Proposition 3 and a total of 32 votes cast AGAINST the Proposition, resulting in a majority of 23 votes cast IN FAVOR OF Proposition 3. The Proposition was therefore duly CARRIED by a majority of the votes cast by the qualified electors voting at the Election. There was a total of 55 votes cast IN FAVOR OF Proposition 4 and a total of 32 votes cast AGAINST the Proposition, resulting in a majority of 23 votes cast IN FAVOR OF Proposition 4. The Proposition was therefore duly CARRIED by a majority of the votes cast by the qualified electors voting at the Election. There was a total of 58 votes cast IN FAVOR OF Proposition 5 and a total of 29 votes cast AGAINST the Proposition, resulting in a majority of 29 votes cast IN FAVOR OF Proposition 5. The Proposition was therefore duly CARRIED by a majority of the votes cast by the qualified electors voting at the Election.

SECTION 3. Promulgation of Election Result. The results of said election shall be promulgated by publication in the manner provided by law, after receipt from the Secretary of State's office of the actual costs of the election, as required by Act 205 of the Regular Session of the Legislature of Louisiana for the year 2019.

SECTION 4. Declaration. The foregoing results of the Election are hereby declared by this Governing Authority and shall be published as required by law.

SECTION 5. Procès Verbal. A Procès Verbal of the canvass of the returns of the Election shall be made and a certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, who shall record the same in his office; another certified copy thereof shall be forwarded to the Clerk of Court and Ex-Officio Recorder of Mortgages in and for the Parish of Caddo, who shall record the same in the Mortgage Records of said Parish; and another copy thereof shall be retained in the archives of this Governing Authority.
