RESOLUTION NO. 2026-15

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF
NEWBERRY AUTHORIZING THE TOWNSHIP MANAGER TO TRANSFER
FUNDS BETWEEN APPROVED FINANCIAL INSTITUTIONS WITHIN THE
SAME TOWNSHIP FUND**

WHEREAS, Newberry Township (“Township”) is a second class township duly organized and existing under the Second Class Township Code; and

WHEREAS, the Township maintains various Township funds in approved banking and investment institutions for the efficient management of Township finances; and

WHEREAS, from time to time it is necessary and appropriate to transfer funds between approved financial institutions for purposes including cash management, investment purposes, liquidity, and operational efficiency; and

WHEREAS, the Board of Supervisors desires to authorize the Township Manager to administratively transfer funds between approved financial institutions, provided such transfers remain within the same Township fund and do not constitute interfund transfers or budget amendments.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Newberry Township, to do the following:

SECTION 1. The Township Manager is hereby authorized to approve and direct transfers of Township funds between approved banking institutions, investment accounts, and financial entities utilized by the Township, including PLGIT accounts, provided such transfers remain within the same designated Township fund.

SECTION 2. This authorization shall not permit transfers between separate Township funds, expenditures not otherwise authorized by the approved Township budget, or establishment of new financial accounts not previously approved by the Board of Supervisors.


SECTION 3. The Township Manager shall maintain appropriate documentation of all such transfers, and such transfers shall be reflected within the Township's financial records.

SECTION 4. This Resolution shall be effective immediately.


