**RESOLUTION NO. 2026-16**

**AUTHORIZING TRANSFER RECREATION FUNDS AND OPENING  
A NEW PLGIT RECREATION ACCOUNT**

**WHEREAS**, Newberry Township maintains restricted Recreation funds; and

**WHEREAS**, the Board of Supervisors desires to optimize safety, liquidity, and yield of said funds through the Pennsylvania Local Government Investment Trust (PLGIT);

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of Newberry Township that:

**SECTION 1 Account Opening.**

The Township Comptroller (Treasurer) is authorized to open a new PLGIT Recreation Account in the name of Newberry Township for the deposit and investment of restricted Recreation revenues.

**SECTION 2 Authorized Transfer.**

The Comptroller (Treasurer) is authorized and directed to transfer One Hundred Fifty Thousand Dollars (\$150,000) from the Township's Recreation Account at ACNB Bank (formerly Traditions), account ending X18333, to the newly established PLGIT Fire Tax Account.

**SECTION 3 Use/Restriction of Funds.**

All funds transferred shall remain restricted for Recreation purposes and accounted for accordingly; this action constitutes a change in depository/investment only, not an interfund transfer.

**SECTION 4 Signatories.**

The Township Manager and Comptroller (Treasurer) are designated as authorized signers on the PLGIT Fire Tax Account. The Township Secretary is authorized to attest and affix the Township seal as required.

**SECTION 5 Documents & Implementation.**

The Township Manager, Comptroller (Treasurer), and Township Secretary are authorized to execute all forms, resolutions, signature cards, and certifications necessary to open and maintain the PLGIT account and to complete the transfer described herein.


**SECTION 6 Effective Date.**


This Resolution shall take effect immediately upon adoption.
