



Supervisors and Staff,

The department handled 1258 calls for the month of July 2025. Listing calls by criteria: 2 Agg Assaults, 4 Burglaries, 15 Thefts, 1 Motor Vehicle Theft, 4 Drug Offenses, 8 DUI's, 11 Simple Assaults, 1 Harassment, and 12 all other offenses. Additionally, officers responded to and investigated 1200 other calls for service including 21 Domestic related incidents and 19 traffic accidents. They issued 105 traffic citations, 175 warnings, issued 13 non-traffic citations and made 40 misdemeanor/felony criminal arrests.

- Cly Road Design Proceeding for Submission of DEP part II permit, NPDES permitting, and HOP.



- UV Upgrade Part II Permit Re-submitted at the end June to DEP. Waiting on Permit and completing Construction Drawings Currently 95% Complete.
- Meeting with Public was held on 6/26/25 to review the Cly Road Project.
- Process Solutions has provided a proposal to provide the UV equipment through Costars. Waiting on the permit from DEP to sign the pre-purchase agreement for the equipment based on the board approval of the purchase at the June Board meeting. Currently the equipment is 22 weeks out.

### Newberry Township Board of Supervisors Treasurer's Report August 26, 2025

- The insurance renewal for the Township has been submitted to Murray Insurance for quotes for the 2025-2026 timeframe.
- The budgeting process is beginning for the year 2026. The first budget meeting will be held September 9, 2025.

The Events Committee has been working on the three (3) events scheduled for the remainder of 2025.

The concession stand at Shelley Park is ready for use at the September 20<sup>th</sup> Music in the Park event thanks to Tony Miller and his many helpers.

Planning is almost complete for the September 20<sup>th</sup> event scheduled from 4-9 pm with the cost of Corrina Rose and the Famous Rumors Band being covered by sponsors. The Susquehanna Fire Department will provide fire police for this event. Port-a-potties will be provided by Walter's. Parking will be handled by the fire police. Any other needs will be provided by committee members.

The Harvest Moon Festival is scheduled for October 4<sup>th</sup> at the Shoppes at Newberrytown from 4-9 pm. A meeting was held with Angie (Shoppes Representative) and committee members on Saturday, August 16<sup>th</sup> to go over the area layout, rules, guidelines and other pertinent information related to the event. Included will be kid's games, music, Music Bingo, chili cookoff and bonfire.

The Events Committee was asked to help by the Parks & Rec Board at a 5K race scheduled for November 1<sup>st</sup>. However, this event has been postponed until 2026.

The Christmas Tree Lighting event is being held on Friday, November 21<sup>st</sup> at MESB with the time TBD. Planning is underway to include Santa, food, music, Officer Barkley, Snow Maker, Igloo and lighting the tree. Specific details are still in the works.

### > Comprehensive Plan Steering Committee

A resolution will be presented to form a Steering Committee for the Comprehensive Plan. The Township will begin soliciting applicants to serve on this committee.

### > Personnel – Sewer Administrator

The Township has begun a talent search for the Sewer Administrator position.

### > 2025 Budget Preparation

Budget discussions for 2025 have begun, with initial meetings scheduled with Department Heads.

### Employee Benefits

Jane and I met with Benecon to review health plan options for 2026 and discuss anticipated changes in coverage and costs.

### > Sewer/DEP Compliance

- Ongoing updates on Hess Mobile Home Park and other Act 537 compliance issues.
- Continued coordination with Brent Zeiders and Brandt regarding sewage enforcement follow-up.

### > Township Internet/IT Infrastructure

The Township recently experienced outages affecting both the Administration Office and Police Department. We are reviewing redundancy and backup options to ensure continuity of operations.
