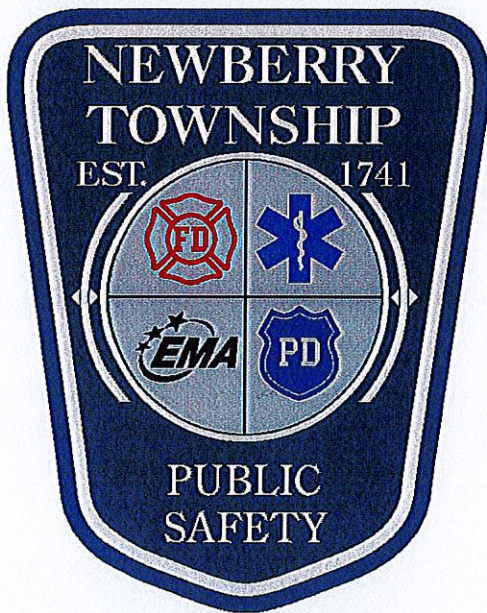

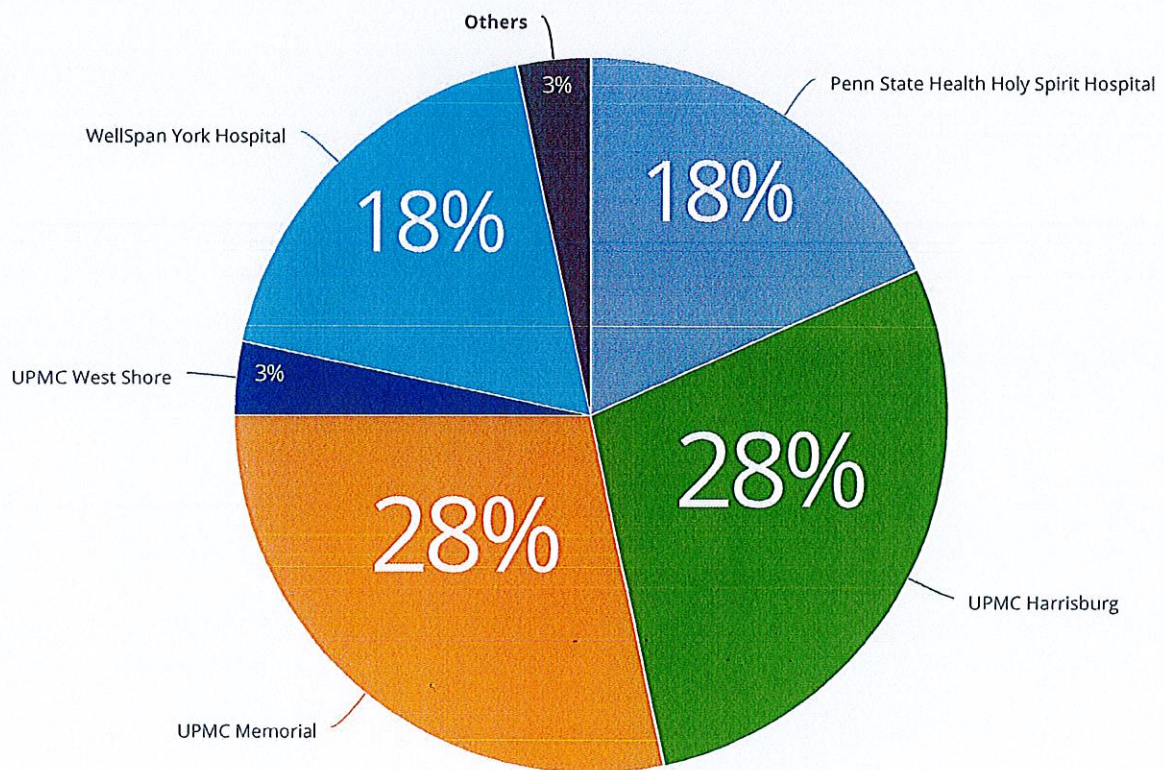

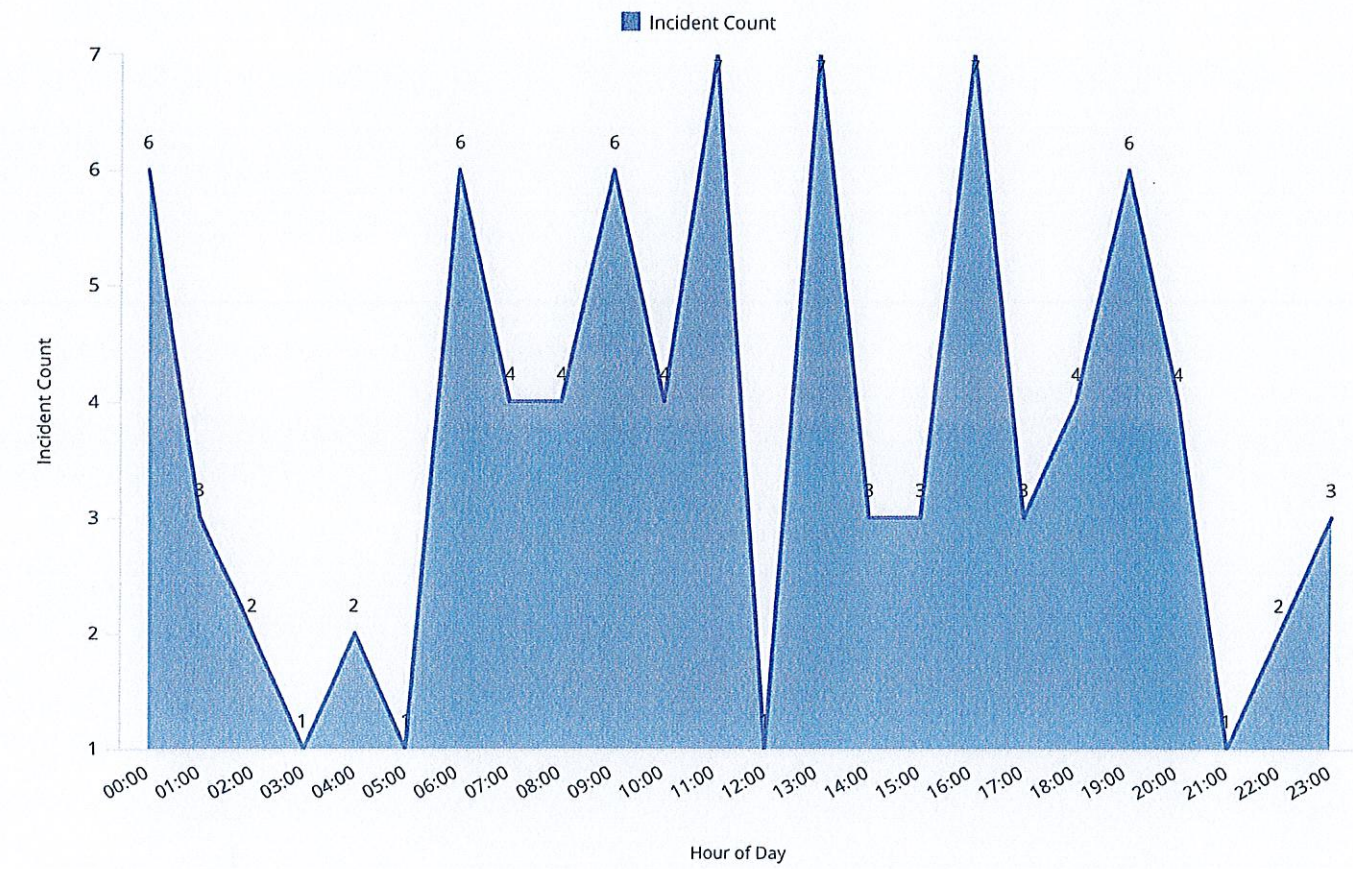

Took core samples for mix designs on Sipe Road and Hill Drive for cement stabilization this year.

Wash and clean trucks and equipment after each storm.

Service all the trucks and start on equipment.

Took the Backhoe up to Cat for the 1000-hour service as it was scheduled for all the oils to be changed and some other adjustments. All oil samples came back good.

Pre-treating every road in the Township for this storm coming up to help with removal. The temperatures will be colder than what salt works at, we will not be salting through the duration of this storm. Roads will be covered and snow will be built up on them. We will salt them when done and continue cleaning up after the event. It is going to be a long duration event with drifting snow, Roads will not be perfect but we will keep them passable to the best of our ability.

Grants & Funding

- The Township has been awarded a \$161,000 DCED PA Small Water and Sewer Grant for the Cly Road Sewer Extension Project.
- The Township has been awarded a \$192,400 DCNR C2P2 Grant for improvements to Terry Dolan Memorial Park.
- The Township has been awarded a \$200,000 DCED MTF 2025 Grant for the Newberry Park Connectivity Project.
- LSA grant applications for a dump truck, plow, and two culvert projects have been submitted and are awaiting award notifications.
- Coordination continues with Tetra Tech to finalize MESB RACP close-out documentation for submission to the Office of the Budget for reimbursement.

Personnel

- New hires in the Sewer Department continue training and onboarding.
- Recruitment efforts continue to fill one remaining position in the Sewer Department.

2026 Budget

- Staff is operating under the adopted 2026 Budget and tracking expenditures accordingly.

Administration

- Meeting dates for 2026 have been finalized for the Board of Supervisors, Parks and Recreation Board, Events Committee, Zoning Hearing Board, and Planning Commission.
- The Township continues to monitor data center development activity in neighboring municipalities for future discussion with the Board regarding potential ordinance development.

IT & Infrastructure

- Blue Ridge fiber installation has been completed at both the Administration Building and the MESB.
- Windows 11 upgrades are substantially complete, with minor follow-up items remaining.

Comprehensive Plan

- Steering Committee applications have been reviewed and recommendations will be presented to the Board.
- One additional Steering Committee application is still being sought.

Sewer & DEP

- A letter was sent to First Capital Engineering regarding billing discrepancies; no additional updates are available at this time.
- Waste Management billing has been reviewed and confirmed to follow the last Board-approved rate. Final payment has been accepted and no balance remains due.

Fire & Emergency Services

- Coordinated with WellSpan on the use of Township facilities for their interview process.
- A meeting is planned with Newberry Township Fire Department and WellSpan for a tour of the new hospital.

Facilities & Operations

- The Township experienced early snow events; road crews and contracted snow removal companies performed well.
- Minor mechanical equipment issues occurred but did not impact operations.
- Winter operations and equipment readiness continue to be monitored.
