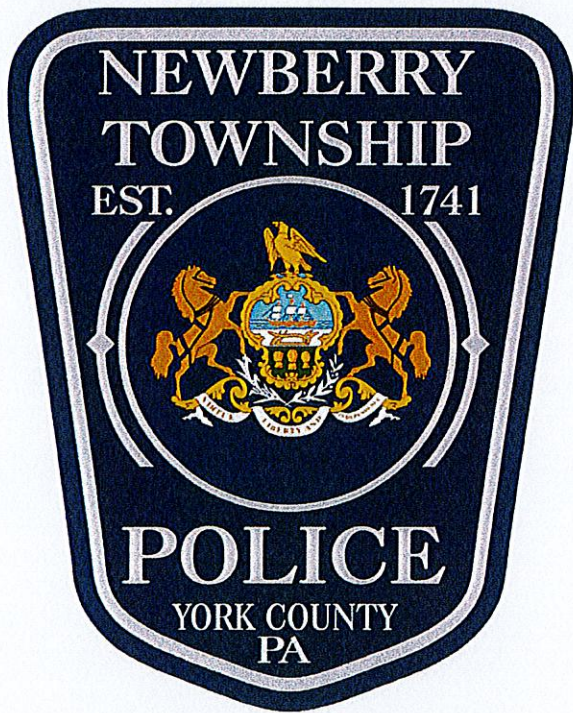

Supervisors and Staff,

The department handled 1169 calls for the month of July, 2026. Listing calls by criteria: 3 Aggravated Assaults, 9 Thefts, 2 Drug Offenses, 7 DUIs, 9 Simple Assaults, 1 Harassment, and 13 all other offenses. Additionally, officers responded to and investigated 1125 other calls for service including 17 Domestic related incidents and 23 traffic accidents. They issued 76 traffic citations, 123 warnings, 13 non-traffic citations, and made 23 misdemeanor/felony criminal arrests.

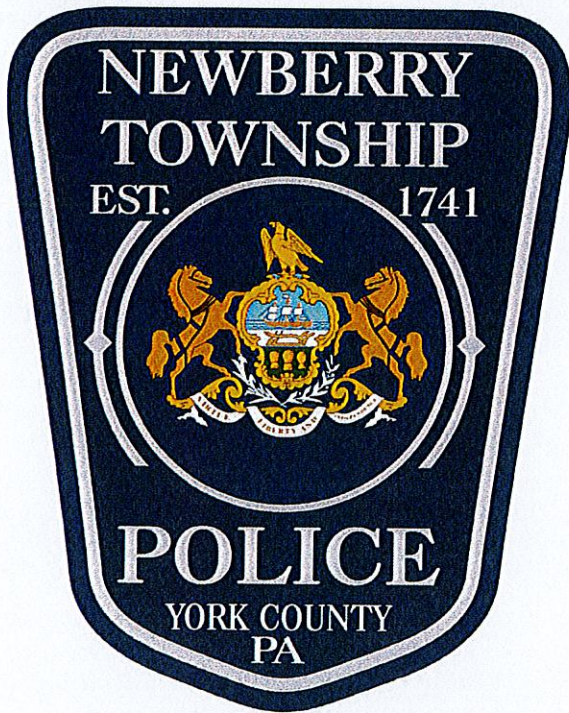

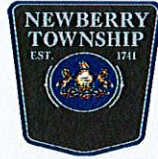

Board of Supervisors Meeting
August 25, 2026**

Grants & Funding

- Continued coordination with Tetra Tech and the Office of the Budget regarding MESB RACP monitoring, reimbursement, special conditions, and close-out requirements.
- Prepared Board resolutions and application materials for the DCED Municipal Assistance Program (MAP) grant and the York County Open Space grant to support the Comprehensive Plan update.
- Continued work on the DCED Multimodal Transportation Fund park-connectivity project and Police Department radio grant documentation.
- Reviewed Local and State LSA grant opportunities for a Highway dump truck and other equipment needs, as well as eligible Fire Department equipment.

Administration

- Received and reviewed three website redesign/hosting proposals and prepared a recommendation for Board consideration, including ADA-accessibility requirements and available 2026 budget funding.
- Continued coordination with the Township Solicitor on ordinances, development matters, personnel issues, Right-to-Know requests, and other operational matters.
- Prepared resolutions, motions, agreements, agenda items, and supporting documentation for upcoming Board action, including corrected vehicle-transfer documents.
- Continued review of purchasing, procurement, and administrative procedures and routine Township operations.

Planning & Development

- Completed review of the draft Solar Ordinance and overlay map following recommendations from the Newberry Township Planning Commission and York County Planning Commission; corrected internal chapter cross-references before Board review.
- Continued review of zoning, land-development, signage, and ordinance matters with the Township Solicitor and professional staff.
- Continued coordination on active development and land-use matters throughout the Township.

Personnel

- Chief of Police Farzad Sharif began employment with the Township on August 3, 2026, and onboarding and transition activities were completed.
- Amanda Runkle began employment as Sewer Billing Coordinator on August 17, 2026.
- Continued recruitment and staffing coordination, including efforts to fill the vacant Sewer Laborer position.

2026 Budget

- The Township budget remains in good standing, with departments continuing to operate within the adopted 2026 Budget.
- Continued monitoring of revenues, expenditures, capital needs, grant matches, and equipment-replacement priorities.
- Began preparation for the 2027 Budget process and upcoming departmental budget review.

IT & Infrastructure

- Township systems and the fiber network continue operating reliably.
- Completed a new network drop and continued planning for equipment-cabinet installation and other internal technology improvements.
- Completed technology-account and access coordination for new staff and continued evaluation of the Township website replacement.

Comprehensive Plan

- The Comprehensive Plan Steering Committee has begun its work, and regular Steering Committee meetings are underway.
- Continued coordination with the York County Planning Commission regarding the planning process, meeting materials, and next steps.
- Prepared MAP grant documentation, including the required Township match, and York County Open Space grant materials to support the Comprehensive Plan update.

Sewer & DEP

- Sewer operations remain stable.
- Continued planning and coordination related to the Cly Road Sewer Extension project.
- Completed onboarding of the new Sewer Billing Coordinator and continued review of billing, account, and department operational procedures.

Fire & Emergency Services

- Continued coordination on the transition of paid fire-driver operations, including reimbursement and implementation details.
- Prepared corrected documentation for the proposed transfer of the 2014 Ford Explorer to the Newberry Township Fire Department Firemen's Relief Association.
- Reviewed potential State LSA funding opportunities for Station 31 equipment, including SCBA and related fire-service needs.

Facilities & Operations

- Reviewed Dolan Park Phase II bids and prepared the low-bid award recommendation for Board consideration.
- Shelley Park picnic tables remain included in the adopted budget, while picnic tables for Dolan Park are included as part of the Phase II project.
- Completed landscaping improvements at the Administration Building and former Police Station; continued summer roadway, stormwater, park, facility, and equipment maintenance activities.
- Prepared the 2027 propane quotation package and updated Township facility tank information for vendor pricing.

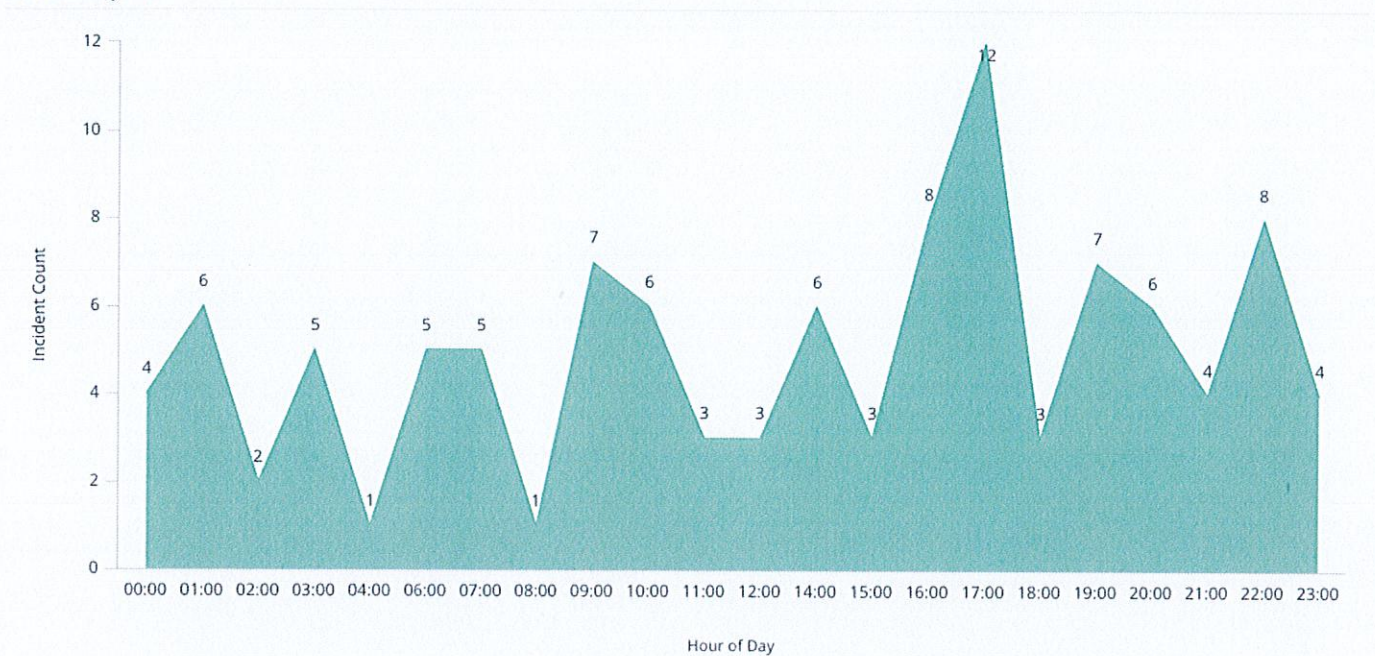

Station 27 – York Haven Fire Company

July 2026 Monthly Report

During the month of July 2026, Station 27 handled a total of 31 calls for service, with 23 incidents occurring within Newberry Township and an additional 8 mutual aid responses outside the township.

Primary incidents included brush fires, structure fires, fire alarms, medical assists, motor vehicle accidents, a motor vehicle accident involving entrapment, wires down, a hazardous materials incident, public safety assists, and a tree down on a structure.

Station 27 personnel contributed approximately 317 total man-hours throughout the month, including:

121 hours dedicated to emergency response activities

96 hours dedicated to training

100 hours supporting fundraising and department activities

Station 27 remained active throughout July while continuing emergency response operations, training, fundraising, and community support activities.

Station 28 – Goldsboro Fire Company

July 2026 Monthly Report

During the month of July 2026, Station 28 handled a total of 27 calls for service, with 25 incidents occurring within Newberry Township and an additional 2 mutual aid responses outside the township.

Incidents included appliance fires, wires and pole fires, fire alarms, medical assists, motor vehicle accidents, outside investigations, structure fires, trash fires, brush fires, vehicle fires, and other public safety incidents.

Station 28 reported approximately 277 total activity hours during July, including:

215 hours dedicated to emergency response activities

62 hours dedicated to training

Station 28 continued to remain active in emergency response, training, and community support throughout the township.

Station 31 – Newberry Township Fire Department

July 2026 Monthly Report

During the month of July 2026, Station 31 handled a total of 76 calls for service, with 63 incidents occurring within Newberry Township and an additional 13 mutual aid responses outside the township.

The department responded to a wide variety of emergencies including motor vehicle accidents, structure fires, fire alarms, wires and pole fires, medical assists, brush fires, fire police assignments, a basic rescue, an outside gas leak, a carbon monoxide alarm, a vehicle fire, an outside investigation, and a landing zone.

Station 31 reported approximately 725 total activity hours throughout July while continuing emergency response operations, training, fundraising, and community activities.

One of the month's most significant incidents occurred on July 13, when Station 31 and numerous mutual aid departments responded to a well-advanced residential structure fire on Pines Road. Crews operated for an extended period in high-temperature conditions. Two Newberry Township firefighters were transported for heat-related medical concerns and were later released.

July also brought a period of significant storm activity, resulting in numerous wires and pole fires, brush fires, and other storm-related emergencies throughout the township.

Station 31 remained highly active throughout the month while maintaining operational readiness for both township and mutual aid responses.

Combined Fire Service Activity

During July 2026, the three fire departments serving Newberry Township collectively handled 134 calls for service.

Of those responses:

111 incidents occurred within Newberry Township

23 mutual aid responses occurred outside Newberry Township

The three departments reported a combined 1,319 activity hours during the month based upon the information submitted
