**A RESOLUTION OF THE BOARD OF SUPERVISORS OF NEWBERRY TOWNSHIP, YORK
COUNTY, PENNSYLVANIA, AUTHORIZING THE SUBMISSION OF A BYRNE JUSTICE
ASSISTANCE GRANT APPLICATION AND DESIGNATING AUTHORIZED OFFICIALS
FOR THE NEWBERRY TOWNSHIP PUBLIC SAFETY RADIO MODERNIZATION
PROJECT.**

WHEREAS, Newberry Township desires to improve and modernize police and public safety radio communications equipment for the benefit of emergency response, officer safety, interoperability, and public safety operations;

WHEREAS, the Pennsylvania Commission on Crime and Delinquency (PCCD) administers the Byrne Justice Assistance Grant (JAG) Program, including the 2026/27 JAG Single Solicitation - Local Initiatives funding opportunity;

WHEREAS, Newberry Township seeks Byrne Justice Assistance Grant funding in an amount not to exceed Two Hundred Fifty Thousand Dollars (\$250,000) to support the Newberry Township Public Safety Radio Modernization Project;

WHEREAS, the requested grant funds are intended to assist the Township with the purchase, programming, installation, testing, deployment, and related implementation of radios and public safety communications equipment; and

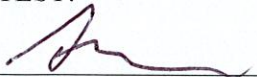
WHEREAS, the Board of Supervisors finds that the project serves a valid public purpose and is in the best interest of Newberry Township, its residents, visitors, employees, police officers, emergency responders, and regional public safety partners.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of Newberry Township, York County, Pennsylvania, at a regular public meeting held on July 28, 2026, as follows:

- 1. Authorization to Apply.** Newberry Township is authorized to request and submit an application for Byrne Justice Assistance Grant (JAG) funding, in an amount not to exceed \$250,000, for the Newberry Township Public Safety Radio Modernization Project.
- 2. Authorized Officials.** Aaron Schwartz, Township Manager, and Mario Eckert, Chairman of the Board of Supervisors, are hereby designated and authorized as officials of Newberry Township to execute, certify, submit, and deliver all applications, certifications, agreements, amendments, reports, reimbursement requests, and other documents required by PCCD or the Commonwealth of Pennsylvania in connection with the grant application and any resulting grant award.
- 3. Further Action.** The proper officers, officials, employees, consultants, and agents of Newberry Township are authorized and directed to take any and all actions necessary or appropriate to carry out the purpose and intent of this Resolution and to facilitate the submission, acceptance, administration, and closeout of the requested grant funds.
- 4. Effective Date.** This Resolution shall become effective immediately upon adoption by the Board of Supervisors.

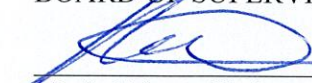

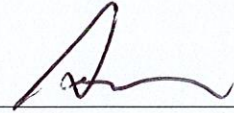
