Resolution 2021-20/2022 Tax Millage Rates

Discussion started about the fire tax. Chairman Eckert wants to hold on implementing the fire tax because he does not want to raise taxes. Supervisor Kirkpatrick discussed the cost to run a Fire Department and that is a lot of fundraising that must be done. Vice Chair Kauffman brought up selling the Sewer utility and use that money to put towards the Fire Department. Each Fire Chief spoke about the lack of funds each department has and why the fire tax is a good thing. The money can sit until needed to the departments. Solicitor Sanders discussed the CARES money and how it is allowed to be used. Tony Miller said that some of the CAREs money can be given to the Fire Departments if they can prove they lost revenue due to COVID. Rob Harkins spoke about why he is in favor of the fire tax. Debra Popp asked if the Public Safety position is paid and where the money is coming from. The supervisors said the money is coming from the General Fund.

MOTION by Supervisor Kirkpatrick to approve the Solicitor to draw up a Resolution to take

\$75,000 CARES Act money for the Fire Departments. The motion, seconded by Vice

Chair Kauffman, carried unanimously.

MOTION by Supervisor Kirkpatrick to approve Resolution 2021-20. The motion, seconded by

Supervisor Wintermyer, carried with 4 ayes and 1 nay.

Resolution 2021-21/ 2022 Budget

Debra Popp asked where the Money Market and Hydrant Funds were in the budget. Comptroller Jane Deamer responded and said that the money is labeled under the General Fund per our CPAs recommendation.
