Chairman Harkins and stated that only the initial \$7,500 for phase 1 of the exploration because the sale did not go through. Public Safety - Chief Lutz

York Haven Fire Department is still selling tickets for their chainsaw and leaf blower raffle. Local fire departments conducted an advanced technical rescue drill at the sewer plant.

Police Department - Chief Lutz

Chef Lutz thanked all of the first responders who were at the World of Outlaws race at BAPS Motor Speedway in anticipation of a very large crowd. National Night Out will be on August 1st at BAPS Motor Speedway starting at 6:00 p.m. The second annual Taser Memorial Golf Tournament will be held on September 1, 2023. All proceeds benefit the Police Department's Non-Profit organization. Newberry Township Police Department became one of 30 Departments in the state of Pennsylvania to hold Premier Agency Status with the Pennsylvania Law Enforcement Accreditation Commission.

Supervisor Kirkpatrick noted that 7 towing agencies met in order to put billing information together. They are hopeful to finalize the Towing Ordinance by the end of September.

Supervisor's Report Continued

Chairman Harkins noted that he wants to begin moving towards putting walking trails on the property that Newberry Township owns on York Haven Road. Supervisor Wintermyer is concerned that the "lower end" of the township has several parks already, while the "upper end" has very few. Options for mitigating this issue were briefly discussed, and it was concluded that the Supervisors would explore this situation further.

NEW BUSINESS

Contract renewal for Penn Strategies/ grant writer. Jason Fitzgerald

MOTION By Supervisor Kirkpatrick to renew the one-year contract with Penn Strategies on the

condition of a 30 day out clause. Seconded by Supervisor Kauffman, carried

unanimously.

DISCUSSION Mr. Fitzgerald spoke briefly about the status of the current grants that he is working on.

These include the Pennsylvania Commission on Crime and Delinquency grant (\$151,750), State LSA Grant (\$250,277), a secondary State LSA grant for the Newberry Township Police Department (slightly over \$99,000), FEMA Safer Grant for the Fire Department (\$306,000), EDCDI Grant for the Multi-Purpose building (slightly over \$100,000), and continuing work on the COVID ARPA funds. Four grants are currently pending approval. These are the Greenway Trails and Recreation Program Grant, the FEMA AFG Grant, the PennDOT multimodal for Pleasant Drive Bridge replacement, and the second round of the Small Water and Sewer Grant. Upcoming grant opportunities include the York County LSA Grant, the Statewide LSA Grant for culverts, and the Department of Justice JAG Grant for tasers.

During the motion the Supervisors asked for clarification regarding the 30 day out clause. It was discussed that this means that the Board of Supervisors may dismiss the grant writer at any time within a 30-day period of renewal.

Approval of 2022 Audit/ Financial Statement

MOTION By Supervisor Kirkpatrick to approve the advertisement of the 2022 Audit/ Financial

statement presented by Stephen Rock, Zelenkofske Axelrod LLC. Seconded by Vice-

Chairman Shellenhamer, carried unanimously.

DISCUSSION Mr. Johnson and Mr. Rock of Zelenkofske Axelrod LLC. presented a brief statement

regarding the audit which was conducted. No problems were found during the audit,

and it was noted that the staff was very open and easy to work with during this process.

It was concluded that Newberry Township is in good financial standing.

siding, curbing and brick work has been started.

Steven Toomey, 160 Cragmoor Rd – Asked about the status of the building, and what percentage of the work has been completed. Chairman Harkins estimated that the

building is 60-65% completed.

Engineer Bill Rudy noted that the sewer project for the building is about three weeks away from initiation, pending arrival of materials. The project is expected to take 3 weeks for the gravity sewer and an additional week to drill the low-pressure system.
