Township Manager said the company Gordian did a presentation on how the process works. Tony explained how the bidding is done within the Keystone Purchasing Network. Chairman Eckert said there is a need for the building because the current building can no longer house the Police Department due to size. The board is seeking other avenues for funding so it will not affect taxpayers. Chairman Eckert said the Township did not make the decision to end EMS services. The Newberry Township Fire Department decided to end its EMS services and they do not answer to the Township. Vice-Chair said the project is not being rushed and a lot of thought/time has gone into it. All meetings have been open to the public and streamed so the public can come and give input.

Discuss Plans for multi-use emergency services twp building/Lobar Associates

Chairman Eckert said the layout of the building has been decided and are currently working on Mechanical options. Supervisor Wintermyer said the Township is picking the lowest cost to do the building. Township Manager Tony Miller said he will talk to the engineer Bill Rudy to see if he can get an electronic copy of the plans to put on the website. The plans for the building are on display currently in the meeting room at the Administration building. Tony Miller said he received feedback from the grant writer that PEMA said we can self-delegate the building as a shelter for the residents. The grant writer is
