RESOLUTION NO. 2026-20

A RESOLUTION OF THE BOARD OF SUPERVISORS OF NEWBERRY TOWNSHIP, YORK COUNTY, PENNSYLVANIA, AUTHORIZING THE SUBMISSION OF AN APPLICATION TO THE COMMONWEALTH FINANCING AUTHORITY FOR A MULTIMODAL TRANSPORTATION FUND GRANT IN AN AMOUNT NOT TO EXCEED \$425,000 FOR THE NEWBERRY TOWNSHIP PARK COMMUNITY CONNECTIVITY PROJECT.

WHEREAS, Newberry Township (the "Township") is a township of the second class located in York County, Pennsylvania; and

WHEREAS, the Commonwealth Financing Authority administers the Multimodal Transportation Fund, which provides financial assistance for transportation improvement projects; and

WHEREAS, the Township desires to submit an application for grant funding for the "Newberry Township Park Community Connectivity Project"; and

WHEREAS, the proposed project will construct a reinforced-concrete pedestrian tunnel beneath State Route 382 near Long Lane, together with approximately 135 linear feet of sidewalk, guiderail, lighting, stormwater improvements, earthwork, permanent stabilization, erosion and sedimentation controls, traffic-control measures, and related improvements; and

WHEREAS, the project will provide a safer, grade-separated pedestrian and bicycle connection between nearby residential neighborhoods and the Township park and will improve public safety, accessibility, and multimodal connectivity; and

WHEREAS, the Board of Supervisors desires to request a Multimodal Transportation Fund grant in an amount not to exceed Four Hundred Twenty-Five Thousand Dollars (\$425,000.00) for eligible project costs.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Newberry Township, York County, Pennsylvania, as follows:

Section 1. Grant Application Authorized. The Board of Supervisors hereby authorizes and approves the submission of an application to the Commonwealth Financing Authority for a Multimodal Transportation Fund grant in an amount not to exceed Four Hundred Twenty-Five Thousand Dollars (\$425,000.00) for the Newberry Township Park Community Connectivity Project.

Section 2. Project Scope. The grant funds shall be used for eligible costs associated with the design, permitting, bidding, construction, inspection, administration, and completion of the pedestrian tunnel beneath State Route 382 and the related sidewalk, guiderail, lighting, stormwater, grading, stabilization, erosion-control, traffic-control, and other necessary transportation improvements.

Section 3. Authorized Officials. Mario Eckert, Chairman of the Board of Supervisors, and Aaron Schwartz, Township Manager, are hereby designated as authorized officials of the Township and are authorized, acting individually or together as required, to sign, submit, certify, and execute the grant application and all related forms, agreements, certifications, amendments, reimbursement requests, closeout documents, and other materials necessary to obtain and administer the grant.

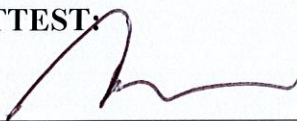
Section 4. Grant Acceptance and Administration. If the grant is awarded, the authorized officials are further authorized to accept the award on behalf of the Township, execute the grant agreement and related documents, and take all actions necessary to implement and administer the project, subject to the terms of the grant award and any additional approvals required by the Board of Supervisors for contracts, expenditures, or project changes.

Section 5. Local Match Waiver. The Township requests a waiver of any local matching-fund requirement to the extent permitted by applicable law and program guidelines. This Resolution does not commit Township funds beyond amounts separately budgeted, appropriated, or approved by the Board of Supervisors.

Section 6. Effective Date. This Resolution shall become effective immediately upon adoption.

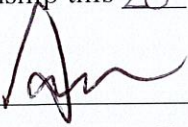
