## ADOPTING THE NEWBERRY TOWNSHIP PROCUREMENT & PURCHASING POLICY

**WHEREAS**, the Board of Supervisors of Newberry Township recognizes the need for a clear, consistent, and legally compliant process for the procurement of goods and services across all Township departments; and

WHEREAS, the Pennsylvania Second Class Township Code establishes requirements for the purchasing and contracting of municipal goods and services, including the solicitation of quotes and formal competitive bidding based on dollar thresholds set annually by the Department of Community and Economic Development (DCED); and

**WHEREAS**, it is the intent of the Board of Supervisors to ensure that all Township purchasing activities are conducted in a transparent, ethical, and fiscally responsible manner, with proper internal controls and oversight; and

**WHEREAS**, the Township Manager has prepared a comprehensive *Procurement & Purchasing Policy* that establishes standardized procedures for purchasing, bidding, recordkeeping, and emergency procurements for all departments of Newberry Township; and

**WHEREAS**, the Board of Supervisors finds it in the best interest of the Township to formally adopt said policy to provide guidance and accountability in the expenditure of public funds.

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Supervisors of Newberry Township, York County, Pennsylvania, hereby adopts the *Newberry Township Procurement & Purchasing Policy*, effective immediately upon adoption, and directs the Township Manager to implement, administer, and enforce the provisions contained therein.

**BE IT FURTHER RESOLVED**, that all prior purchasing or procurement procedures inconsistent with this policy are hereby repealed, and this resolution shall remain in effect until amended or repealed by the Board of Supervisors.
