RESOLUTION NO. 2025-32**

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF NEWBERRY ("TOWNSHIP"), YORK COUNTY, PENNSYLVANIA AUTHORIZING THE FILING OF AN APPLICATION FOR FUNDING TO THE COMMONWEALTH OF PENNSYLVANIA FOR REDEVELOPMENT ASSISTANCE CAPITAL PROGRAM ("RACP") FUNDING IN THE AMOUNT OF, AND NOT TO EXCEED, \$1,500,000 (ONE MILLION FIVE HUNDRED THOUSAND DOLLARS) FOR A PUBLIC BUILDING RENOVATION PROJECT ("PROJECT") IN THE TOWNSHIP.**

WHEREAS, the Commonwealth Office of the Budget has available funds through the RACP program for civic project purposes; and

WHEREAS, the PROJECT includes renovation of the existing Administration Building, at 1915 Old Trail Road, in Etters, PA, which is in dire need of repair and upgrades, as well as replacement of the roof of Newberry Township's Public Works garage, located directly across the street from the Administration Building.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF NEWBERRY TOWNSHIP as follows:

- 1) The TOWNSHIP does hereby designate Aaron Schwartz as the TOWNSHIP official to execute all documents between the TOWNSHIP and the Pennsylvania Office of the Budget to facilitate and assist in obtaining the requested grant and,
- 2) The TOWNSHIP approves its designated consultant, Grant Success Lab, LLC, to assist in all administrative matters associated with the RACP application.

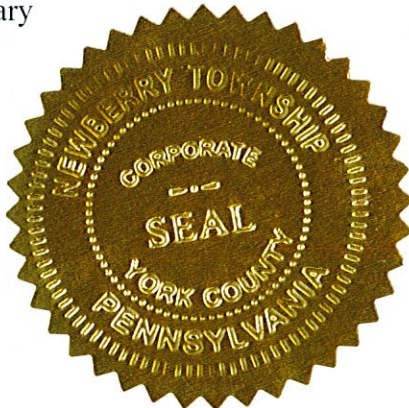

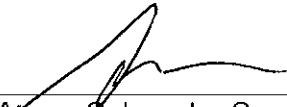
