

COBALT PARTNERS, INC., NOTICE OF PRIVACY PRACTICES

INTRODUCTION

Cobalt Partners, Inc. (**"Company"** or **"We"**) respect your privacy and are committed to protecting it through our compliance with this policy. This policy describes the types of information we may collect from you or that you may provide when you visit the website <u>cobalthealth.us</u> (our **"Website**") and our practices for collecting, using, maintaining, protecting, and disclosing that information.

This policy applies to information we collect:

- On this Website.
- In email, text, and other electronic messages between you and this Website.
- Through mobile and desktop applications you download from this Website, which provide dedicated non-browser-based interaction between you and this Website.

It does not apply to information collected by:

- Us offline or through any other means, including on any other website operated by Company or any third party including our affiliates and subsidiaries; or
- Any third party (including our affiliates and subsidiaries), including through any application or content (including advertising) that may link to or be accessible from or on the Website.

Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it.

This policy may change from time to time (see Changes to Our Policy). PERSONAL INFORMATION PRIVACY PROTECTION POLICY

Cobalt Partners, Inc. is committed to safeguarding the Personal Information we receive from our members and groups. We impose standards to maintain the confidentiality of Personal Information through the use of physical, technical, and administrative safeguards.

Our policy prohibits the unlawful disclosure of Personal Information. We share it externally only where federal and state law allow or requires it. Internally, we limit access, use and disclosure of personal Information to be in line with the job duties of our associates, as well as applicable law.

WHAT PERSONAL INFORMTION WE COLLECT ABOUT YOU AND HOW WE COLLECT IT

We collect this information:

- From third parties, for example, our business partners.

HEALTH INSURANCE PORTABILITY AND ACCOUNTABILITY ACT OF 1996 (HIPAA NOTICE OF PRIVACY PRACTICES)

INFORMATION YOU PROVIDE TO US

The information we collect on or through our website may include:

- Information that you provide by filling in forms on our Website. This includes information provided at the time of registering to use our Website.
- Records and copies of your correspondence (including email addresses) if you contact us.

INFORMATION WE COLLECT THROUGH AUTOMATIC DATA COLLECTION TECHNOLOGIES

As you navigate through and interact with our website, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

- Details of your visits to our Website, including traffic data, location data, and other communication data and the resources that you
 access and use on the Website.
- Information about your computer and internet connection, including your IP address, operating system, and browser type.

We do not collect personal information automatically, but we may tie this information to personal information about you that we collect from other sources, or you provide to us.

HOW WE USE YOUR INFORMATION

We use information that we collect about you or that you provide to us, including any personal information:

- To fulfill any other purpose for which you provide it.
- To provide you with notices about your account.

DISCLOSURE OF YOUR INFORMATION

We may disclose aggregated information about our users, and information that does not identify any individual, without restriction. We may disclose personal information that we collect, or you provide as described in this privacy policy:

- To our subsidiaries and affiliates.
- To contractors, service providers, and other third parties we use to support our business and who are bound by contractual obligations to keep personal information confidential and use it only for the purposes for which we disclose it to them.

We may also disclose your personal information:

- To comply with any court order, law, or legal process, including to respond to any government or regulatory request.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of Cobalt Partners, Inc., our customers, or others. This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.

DATA SECURITY

We have implemented measures designed to secure your personal information from accidental loss and from unauthorized access, use, alteration, and disclosure. The safety and security of your information also depends on you. Where we have given you (or where you have chosen) a password for access to certain parts of our website, you are responsible for keeping this password confidential. We ask you not to share your password with anyone. We urge you to be careful about giving out information in public areas of the Website like message boards.
