UNDER THIS PROGRAM, KHEYTI HELPS SMALLHOLDER FARMERS BECOME CLIMATE RESILIENT BY PROVIDING THEM ACCESS TO LOW-COST GREENHOUSE TECHNOLOGIES AND GIVING THEM FREE TRAINING, EDUCATION AND MARKET ACCESS SERVICES. THE PROGRAM WAS LAUNCHED IN 2017 AND REACHED 50 FARMERS IN INDIA AT THE END OF THE YEAR. IN 2019, IT EXTENDED ITS REACH TO 300 FARMERS AND IT AIMS TO REACH 500 FARMERS IN 2020, 2000 FARMERS IN 2021 AND 1 MILLION FARMERS OVER THE NEXT 10 YEARS. THE PROGRAM COSTS INCURRED IN THE US PRIMARILY INCLUDE INTEREST COSTS AND THE PURCHASE OF MATERIALS. SINCE THE ACTIVITY IS CARRIED OUT THROUGH ITS 100% OWNED SUBSIDIARY IN INDIA, ADDITIONAL COSTS OF THE PROGRAM HAVE BEEN INCLUDED IN THE REPORTING OF THE SUBSIDIARY.
