THE PROGRAM WAS LAUNCHED IN 2017 AND REACHED 1,000 FARMERS BY THE END OF 2022. IT AIMS TO EXPAND ITS REACH TO 4,000 FARMERS IN 2024 AND 1 MILLION OVER THE NEXT 10 YEARS. THE PROGRAM COSTS INCURRED IN THE US PRIMARILY INCLUDE CONSULTING COSTS FOR DESIGN, ENGINEERING AND PROGRAM.
