**POLICE REPORT:** Review October 2025 police report. Freedom had 15.6 % of the calls.

Pulaski Twp. has voted to join the Regional Police as contracted Services starting January 1, 2026. They are just contracted services and do not have a seat at the table or voting position. There was disappointment with the actions of the officer that was at the Halloween event. Per John Kaercher let the minutes note that there is a new Contracted Services with Pulaski Twp. for 125,000.00 for full service and we passed a motion last month for 2026 Freedom Borough in the amount of \$240,314.92. which if we were a contracted service, it would be 115,314.92 savings approximately.
