Matt Hogue: 125 5th Ave. Would like to talk about curb appeal in town. Specific to road – street signs bent from 2013. Complain about loose gravel on road and walk way, potholes, overgrowth on sidewalks. I don't see the curb appeal at all. I don't want to help anybody in Freedom anymore if we can't clean up the town.

Rachel Smrzlick: 1744 8th Ave. We attended the School Board meeting in April or May to talk about the busses on 8th Ave and the 15-mph speed limit. I have been trying to figure out a way to have the drop off and picking up a better option. Mr. Capeheart said he would have someone contact the Boro office. No one has reached out to the Boro. Any solutions on abandoned houses in the Boro?

Lorrain Fox 1898 7th Ave. 6th Ave. & 18th street used to be mowed all the way to the ground. You can not see at the stop sign. Also, the weeds on Harvey Run Road are bad and you cannot see. Sharon will call PennDOT about Harvey Run Road. Most of Lorraine's complaints were on Freedom School District or New Sewickley twp. not Freedom Boro. Shawn Mason: 655 8th street: requesting an ADA exempt letter for F.O. E. from Freedom Borough for the PA. Lottery.

STREET DEPT. REPORT: Review of street department report.

Ron spoke to BFMA on the meter fee for the water fountain with BFMA will be a 1,000.00. Vandalism on the fountain could be costly to Freedom. I spoke to Harry on the dump truck; he told me to be patient with him. Much discussion was made on this. Council will look for someone to pick up the truck. The catch basin on 6th street has been replaced. We cannot sell the snow plow because it was purchased with a grant. Ron will look around to see if there are options with a different edge that can be flipped. Can we work on some of the punch list that Matt has been talking about? The way the wind blows in this town I can fix the road signs every day.

<u>MAYOR REPORT</u>: Thank you all for the prayers, as I am going through cancer. Harry has insurance on the fire truck in his garage. Sharon also called our carrier and the truck is insured if we own it, even if it is not on our property. It is also brought up at school board meetings how everyone wants more police presence during school pick up times, to help control speeding. Mayor applied for a wish list of 25,000-30,000 to help with memorial sustainability and electrical updates through Rep. Matzies office.

POLICE REPORT: Review July 2025 police report. The increase of percentage this month was due to the increase of the traffic calls. The calculation of payment Freedom only pays 8.8% of all calls. Depending on how the new municipality enters the Regional is how it depends if you have a seat on the board. Regional police are interviewing investors to get a better return on the pensions. Letter was sent to school to see if they would agree to sign a contract after they finish out the grant that they have with the school district which runs for a year and a half ending 2026.
