1. Owner agrees to pay the rate for boarding in effect on the date the pet is checked into the kennel. Owner further agrees that the pet(s) shall not be dismissed from the kennel until all charges are paid in full.

2. Owner agrees to pay all costs and charges for special services requested and any and all veterinary costs for the pet during the time pet (s) is in the care of the kennel. .

3. **If in our judgment, your pet requires medical care**, you agree to be solely responsible for the payment of all medical bills for your pet and you release Rising Star Pet Ranch, Inc., its officers, directors, agents and employees from any and all responsibility for, any claims, damages or debts arising out of ,or related to ,such medical care, including but not limited to, transportation to/from veterinarian and choice of veterinarian or animal hospital.

4. **Kennel business hours are by appointment only**, all drop offs and pickups are by pre-arranged appointments times. I have read the above and understand that I must set a drop off and pickup appointment each time my pet visits the kennel.

5. By signing this contract and leaving said pet(s) with the kennel, owner certifies that all information given about said pet(s) is true and accurate.

6. If applicable, when requesting group play , Owner understands the risks involved in a group setting of dogs Although we offer reasonable care , the unpredictable personality of animals can sometimes lead to injury.

7. The kennel shall exercise reasonable care for the pet(s) while boarding. It is expressly agreed by Owner and kennel that kennel's liability shall in no event exceed the the current chattel value of a pet of the same species or the sum of \$200.00 per animal boarded. .Owner agrees to be solely responsible for any and all acts or behavior of pet(s) while in the care of the kennel.

8. The kennel does not assume and shall not be held responsible for any liability with respect to the pet(s) listed in this agreement, including loss by fire, theft, disease, running away, death, injury to persons or animals , or death or injury to any other animal caused by within named pet(s) during the term of this contract.

9. Owner specifically represents that he or she is the owner of said pet(s) free and clear and that the pet(s) have not been exposed to distemper, hepatitis, parvovirus, Para influenza, canine cough or rabies within the last 30 days.

10. *This contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and the Kennel for this visit and all subsequent visits.*

11. Any controversy or claim arising out of or relating to this contract, or the breach thereof shall be settled in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof.
