- Caregiver and Family Data: Names, contact information, and relationship to the person receiving care, provided for communication and support coordination.

- For Legal or Safety Reasons: When required by law, to protect against harm, or to respond to legal requests

4. Data Security

- We take data protection seriously. We use encryption, secure servers, and access controls to protect sensitive information. However, no digital system is 100% secure, and we cannot guarantee absolute security.
