Registration: Please register by Nov. 28th, 2022

Booth Location: The Bazaar will take place in the gymnasium. We will set up in a large loop with approximately 10 feet of space. Spaces will be assigned based on the product you sell. If there are enough vendors we can create a center aisle, also.

Exhibit Space:

Table and chairs are **NOT PROVIDED**. Absolutely nothing is to be taped or nailed to the walls or floors. Take precautions to not scratch the floor.

Publicity:

Publicity materials will be supplied by Ridgefield Art Association, the YMCA and the city of Ridgefield at no cost to exhibitors. Invitations may also be sent via e-mail.

Rules and Regulations:

- a) No exhibitor shall assign or share the exhibit space without the expressed written consent of the Ridgefield Art Association. Limit of 2 artists per numbered space.
- b) There will be no smoking allowed anywhere at any time.
- c) No food or beverages may be served or sold.
- d) Each vendor is solely responsible for receiving payment for their sales and for collecting and paying any and all sales or business taxes incurred at this bazaar.
- e) The exhibitor will guarantee that either (a) their work is entirely original, or (b) if the work is not original (for any reason), the Artist guarantees that he/she is not infringing on anyone else's rights.

Fire Code:

By order of the Fire Marshal, all booth decorations shall be non-combustible or flame retardant. Sorry, electricity is unavailable.

Liability & Indemnities:

Exhibitor's use of space provided under this agreement shall be at the Exhibitor's sole risk of all loss and damage whatsoever. Ridgefield Art Association shall not be liable or responsible for

any loss, damage, death or injury resulting thereto. All claims of any such loss are hereby waived by the Exhibitor. Exhibitors are advised to obtain insurance to cover exhibit material against damage and loss and public liability insurance against injury to the person or property of others.

Security:

Ridgefield Art Association will exercise reasonable care for the protection of the Exhibitor's materials and display, but the Exhibitor assumes all obligation of risk or loss at all times.

Authorized Signatures:

The Exhibitor, named above, acknowledges the rules, regulations and legal implications of this entire contract. This contract is legally binding between the Exhibitor and Ridgefield Art Association according to the terms and conditions specified herein upon its acceptance by Ridgefield Art Association. This constitutes the entire agreement between the Exhibitor and Ridgefield Art Association and no other agreements should be deemed to exist or binding upon either party. Any and all changes to this agreement must be in writing and approved by Ridgefield Art Association. Ridgefield Art Association reserves the right to cancel this agreement at any time for any reason.
