## Rules & Regulations

# HOW IT WORKS

 Participating teams make enough banana pudding for 200 1 oz cups and bring it to the BBQ in Red Shoes on September 23, 2022.

 Teams designate two (2) official Puddin' Path reps to hand out 1 oz samples of their best banana pudding in the designated contest tent from 10:45
AM - 2:00 PM at the BBQ in Red Shoes.

3. Lunch guests that purchase a Puddin' Pass follow the path to visit each competing team, collect the samples, taste samples, and then vote on their favorite.



4. The winning team gets half the contest entry fees (or can add their winnings to the overall donation) and a trophy at the event! Plus, the title of "Best Banana Pudding in the Middle TN Construction Industry!"



### Rules and Regulations

1) The decision and interpretations of the Rules and Regulations are at the discretion of the AGC staff & CLC Representatives at the contest. Their decisions and interpretations are final.

2) Entry in the BBQ in Red Shoes Puddin' Path contest is due by August 31,
2021 at 2 PM CST. Entry must include the type/title of the banana pudding being entered into the contest or the entry will be considered invalid.

3) Contestant entry is limited to the first 10 registered BBQ in Red Shoes cooking teams that register for the Puddin' Path contest.

4) Each Puddin' Path contestant is required to have exactly two (2) team representatives at their assigned table in the Puddin' Path area from 10:45 AM - 2:00 PM on the date of the BBQ in Red Shoes. These two representatives can be switched out at 12:00 PM and 1:00 PM ONLY. These representatives will be in charge of filling sample cups, handing out sample cups to Puddin' Path participants ONLY, and cleaning up their space in the tent. Any team that leaves a mess at their contest space will be immediately disqualified. Pudding Path representatives that are not one of the 5 people on an official BBQ cooking team will be required to purchase General Admission tickets.

5) Contestants will be allowed to set up their space in the Puddin' Path between 8 AM-10:45 AM on the day of the BBQ in Red Shoes cook-off.

6) Each contestant will be assigned a space on the Puddin' Path in the designated tent. Contestants shall not exceed their designated space. Space will be approximately 6' x 6 '. The contest reserves the right to change this space allotment at any time, as required.

7) The contest will provide the event tent, one 4 ft table for each contestant, sample cups, serving gloves, trash cans, and sample collection boxes for the Puddin' Path.

8) Contestants are required to bring their own storage coolers, chairs, table covering/assigned space decor, and utensils for preparing the sample cups.

9) Each contestant is required to provide enough banana pudding to fill200 2 oz cups.

10) Each contestant is required to keep their banana pudding properly stored (chilled) for the entire event. Banana pudding left out without proper chilled storage before and during the event will not be served to Puddin' Path participants and the team will be disqualified.

11) All banana pudding MUST be onsite and ready to serve no later than 10:30 AM on the day of the BBQ in Red Shoes.

12) All banana pudding should be made by the contestant. Any store-bought or catered banana pudding will be immediately disqualified.

13) All samples should be complete and ready to eat upon issuing to the Puddin' Path participants.

14) All samples should be complete and ready to eat upon issuing to the Puddin' Path participants.

15) All samples must be issued in the sample cups provided by the contest.

16) The following cleanliness and safety rules will apply:

- No use of any tobacco products while in the Puddin' Path.
- Plastic or latex gloves must be worn at all times while filling sample cups and handing samples out to contestants. They must be changed any time the representative wearing the gloves touches anything except the serving utensils or plastic cups.
- Shirts and shoes are required to be worn at all times.
- Each contestant will provide a separate container for washing, rinsing, and sanitizing of serving utensils.

16 (Con't)) The following cleanliness and safety rules will apply (Con't):

- Designated space should be wiped down frequently and space kept clean and clear.
- First aid is not required to be provided by the contest, except at the election of the contest organizer.

17) There will be no refund of entry fees for any reason, except at the election of the contest organizer.

#### 18) No Puddin' Path tickets are included with a company's Puddin' Path registration or sponsorship.

Puddin' Path tickets can be purchased through Will Call or at the event.

CAUSES FOR DISQUALIFICATION & EVICTION of a team, its members and/or guests: A cook team is responsible jointly and severally for its head cook, its team members, Puddin' Path representatives, and its guests.

a) Excessive use of alcoholic beverages or public intoxication with a disturbance.

b) Serving alcoholic beverages to the general public.

c) Use of illegal controlled substances.

d) Foul, abusive or unacceptable language, or any language causing a disturbance.

e) Excessive noise, including but not limited to that generated from speakers, such as radios, CD players, Bluetooth speakers, TVs, public address systems or amplifying equipment unless otherwise determined by the event.

f) Fighting and/or disorderly conduct.

g) Theft, dishonesty, cheating, use of prohibited meats, or any act involving moral turpitude.

h) Use of gas or other auxiliary heat sources inside the cooking device. i) Excessive or continued complaints from teams on any of the above rule infractions shall be considered grounds for immediate disqualification from the contest by CLC Representatives, Organizers, and/or Security. In addition, any violation of the above rules shall be reported to the CLC Board of Directors who may in addition to the above disqualification impose additional penalties upon the team, the head cook, and its members including but not limited to disqualification from competing in CLC events for a period of time not to exceed five years. All complaints of disturbance or violation of quiet time shall be reported to the AGC staff, BBQ in Red Shoes Committee, and AGC Middle TN Board of Directors.
