ADDITIONAL FEE'S

STAY-LATE// TOUCH UP// SECOND LOOK

HOURLY RATE: \$ 50.00 P/ HOUR

(Hourly rate begins at the "finish time" of the contract). Ex. If all styles were finished at 4 PM, and the Bride needs a touch up at 7 PM, the total fee would be 3 hours of standby time.

DESTINATION WEDDING

Pricing varies depending on location and time of year to travel. Lodging and airfare to be included for the stylist up to the end of her services, along with a \$25/day food credit.

TRAVEL FEE'S

\$1.00 P/ MILE

(Travel fees do not apply if the location of the venue, or the location of the site that we will use to perform hair services is within 15 miles of Beaumont, CA).

2nd Artist Needed:

For more than 6 services, a second artist will be required for day of, and a one-time fee of \$100 will be added, in addition to travel fee.

ADD-ON ACCESSORIES

Speak to your stylist about what you have in mind for both the style and budget. Pricing varies based on these factors.

BOOKINGS & RESERVATIONS

A non-refundable deposit of \$50.00 will be required to hold your booking date for trial and/or wedding date (each require their own \$50 deposit) plus \$25 non-refundable deposit for each additional style, along with the completion of this contract. Once all have been completed, your wedding and/or trial date will be reserved.

EX: Bride + 4 styles = \$150 non-refundable deposit required.

*All deposit(s) are non-refundable and non-transferable.

*The deposit(s) will go towards remaining balance, day of.

RESCHEDULING

If the event needs to be rescheduled, and falls within the 45 day grace period, a credit for services owed will be given to the wedding party and a reschedule date will need to be confirmed within 60 days or all services are voided out.

If the event is NOT rescheduled before the 45 day grace period, a partial credit MAY be given to the wedding party and a date of reschedule will need to be confirmed within 60 days or all services are voided out.

CANCELLATION

Cancellations need to be made 45 days before the event date reserved to be eligible for reimbursement (excluding deposits).

In the event that a person(s) of the wedding party cannot make their appointment, and did not cancel their reservation 45 days prior, that individual will be held responsible for the owed amount in full. If that individual refuses to pay, the wedding party will be held accountable for the owed balance.

CHANGES TO HEAD COUNT:

Any change requests to styles being added or deducted from final count must be made via email, within 45 days of event or late fee may be added.

PAYMENT

ALL balances are due in full on the day of scheduled event. Payments can be made using Cash, Venmo, and Zelle.

SUGGESTED All balances due to be paid with cash, and placed into an envelope for the bridal stylist.

Failure of any owed amount due on day of event may result in legal matters.
