III. Approval of Minutes From Last Meeting

Minutes from November 9, 2021 were provided to all members in the November newsletter. A motion to accept the minutes as presented was made by Rita Dunn and seconded by Melissa Morehead.

IV. Committee Reports

Treasurer's Report

- There was discussion about the possibility of a summer schooling show. The discussion was tabled at this time.
- The board agreed there will be no entry fee increase for shows in 2022.

Banquet Committee

- The date has been moved to February 5, 2022. Electronic invitations will be sent by the end of December 2021.
- End of year awards nomination information was received by Melissa Morehead. Susan Hill will assist in procuring awards.
- Silent auction items are needed. Rita Dunn has agreed to coordinate this effort again this year. The need for silent auction services/items will be advertised in the newsletter and on the website.
- Photographs for the year end awards slide show should be submitted to Coy Jo Bays as soon as possible.
- Carolyn Ordal will contact our guest speaker Jose Hernandez to advise of time constraints for his presentation.

- Continuation of Riding High support for 2022 will be tabled until the January 2022 meeting.



08/17/1954 – 12/01/2021**

CDCTS Vice President Alece Ellis passed away on December 1, 2021 after a lengthy struggle with Covid-19. She was an important member of the Board of Directors and will be greatly missed.

Alece could always be found in volunteer mode or helping others! Whether it was at the CDCTS schooling shows, River Glen dressage shows, Scenic Flight dressage shows, working equitation shows, working equitation obstacle schooling days and any clinic involving horses. She always turned up at equine events all over East Tennessee and beyond! She was actively involved with the CDCTS Board of Directors beginning in 2018 when she came on as an alternate. Year after year, she continued to be involved and eventually became the Vice President in 2021. The Board depended on her for direction and guidance when it came to incorporating more western and gaited dressage into the schooling shows and she was willing to take on most any task!

When Alece was not working with CDCTS, she was volunteering her time or working with several other organizations in the equine world as secretary/treasurer, committee member or Judge. Alece was a Licensed Judge for NAWD (North American Western Dressage) and held judging cards for multiple gaited breeds such as:

- IJA Judges License (Dressage and Rail classes)
- Rocky Mountain Horse Association (RMHA Senior)
- Missouri Fox Trotting Association (MFTHBA)
- United Mountain Horse Association (UMH).

She was also the Secretary/Treasurer for FOSH (Friends of Sound Horses) and most recently she became a Licensed Official TD for USAWE in October 2021.

In memory of her dedication to helping riders and their equine partners and to her spirit of volunteering, the CDCTS Board of Directors has unanimously agreed to convert the annual Volunteer of the Year Award to a perpetual trophy beginning with the 2021 Year End Awards. The board also unanimously agreed to nominate Alece Ellis, posthumous, as the first recipient of this award.




