CDCTS MEETING MINUTES, MAY 13, 2021

I. Call to order

The meeting was called to order by CDCTS President Carolyn Ordal at 7:00 p.m. on May 11, 2021 at Fleet Foot Farm, Lenoir City, TN.

II. Roll Call

The following board members were present: Carolyn Ordal, Jean Sullivan, Julie Noe, Melissa Morehead, Alece Ellis, Susan Hill and Julie Hall. The following board members were not present: Rita Dunn and Jeannie Baggett. The following guests were present: Susan Michaud.

III. Approval Of Minutes From Last Meeting

Minutes from April 13, 2021 were provided to all members in the April newsletter. A motion to accept the minutes as presented was made by Alece Ellis and seconded by Melissa Morehead.

IV. Committee Reports

Treasurer's Report:

The Treasurers Report was read by Melissa Morehead. A Motion to accept the Treasurers Report as presented was made by Jean Sullivan and seconded by Susan Hill.

Show Committee:

- CDCTS Schooling Show will be held May 29, 2021 at Winfield Oaks. The Board approved the sale of concession with non-cooked items such as drinks and individually wrapped snacks. Carolyn Ordal will coordinate. Shannon O'Hatnick has agreed to help set up the jump course on Friday, May 28, 2021. Rita Dunn is the Volunteer Coordinator and requested via email that a notice to all CDCTS members be sent requesting volunteers. It was noted volunteer hours was a requirement for Year-End Awards, and this was a good opportunity to earn those hours. There was discussion about allowing vendors to be present during the show. Jean Sullivan was approached by Jeannie-Alan Holt about promoting her horse cookie business. The Board agreed to allow this pending a Business Membership application and approval of property owners. There was also discussion about allowing a tack swap between competitors only. This was pending approval of property owners. Melissa sent the property owner a text message.
- The committee continues to search for a venue for the fall schooling show (September 25).
- The Jennifer Roth clinic for June 26-27, 2021 is full and has a waiting list. Auditors are welcome.
- Rita Dunn and Julie Hall participated in the Working Equitation Clinic and Show held May 7-9, 2021 at Three Bulls Farm in Bulls Gap, TN. The show was managed by Maria and Arielle Blackstone, club members. Working Equitation has three phases – Dressage, Ease of Handling and Ease of Handling Speed, which is timed. Rita and Finale were very popular with the competitors and a great inspiration to all. Rita and Finale placed Second overall in the L5 division, but just by hundredths of a second to the First place winner. Julie and Rudy placed Fourth overall in the L2 Novice A division.

Membership Committee:

Julie Hall reports there are 54 members on the USDF GMO club roster. Carolyn Ordal will visit the Western Dressage Show hosted by Dene Massengil over the upcoming weekend and have Membership Forms available.

Welcome Committee:

There are currently no official members for this committee. Julie Hall has agreed to continue reaching out to new members via email when membership applications are received. New members will also be profiled in the Newsletter as space allows.

Education Committee:

This committee is currently on hold.

CDCTS MEETING MINUTES, MAY 13, 2021- CONTINUED

Social Media Committee:

The committee members of Julie Noe, Jean Sullivan, Susan Hill and Julie Hall met at Sullivan's Restaurant in Maryville to discuss the status of our social media/Facebook presence. There are two CDCTS groups/pages on Facebook – our Page and a Public Group. A lengthy discussion was had about the need to monitor each of those sites for appropriate content and posts that are horse related and in the best interest of CDCTS. It was generally agreed the "Crossroads Dressage & Combined Training Society" FB Page would be for official CDCTS business while the Public Group page would be a more appropriate place for horse related topics of discussion. Rules/guidelines for each page have been updated. The Public Group page name was changed to "Crossroads Dressage & Combined Training Society Discussion Group" and currently has 940 followers. Susan Michaud made a Motion that only CDCTS Board Members would have any administrative role for the CDCTS Facebook page(s) and this was seconded by Julie Hall. Julie Noe will contact the administrators currently listed on both pages, who are not current Board members, to discuss.

By-Laws Committee:

Current members are Alece Ellis, Susan Hill and Julie Hall. No report at this time. A meeting will be organized to discuss the current by-laws and update as needed. The committee will also review and/or establish criteria for charitable donation requests.

V. Old Business:

- Discussion about the location of monthly board meetings. The Board expressed appreciation to Melissa Morehead for her continued support in allowing the club meetings to take place at her facility and often providing food. The Social Media Committee met at Sullivan's Restaurant in Maryville earlier in the month and approached the restaurant management about holding our monthly meeting in the back room. There is a \$50.00 fee associated with holding a gathering however if 12+ people attend and purchase a meal, the \$50.00 would be refunded. It was agreed that Julie Hall would contact Sullivan's in Maryville, to secure the back room for the June 8, 2021 meeting. The initial cost of \$50.00 was approved. It was felt 12+ attendees was realistic however it was suggested we solicit RSVP's prior to the next meeting to ensure we could meet the minimum.
- Due to a delay in delivery of her dressage arena, Dene Massengill would like to rent the club arena. This was previously approved by the Board. Melissa Morehead will deliver the arena, have the contract signed and collect payment on Thursday, May 13, 2021.
- Melissa Morehead has agreed to keep the CDCTS trailer at her farm, and we appreciate that. The Board approved the purchase of new locks.

VI. New Business:

- A lengthy discussion was had about the CDCTS Year-End Awards requirement of 4 volunteer hours. This could potentially pose a problem for the Junior rider/member of the club, who is dependent on an adult for transportation back and forth to club events. It was agreed the requirement of 4 volunteer hours should stand. Several options for Junior rider/member only, allowing accumulation of the required volunteer hours, were recommended and agreed upon by the Board. Junior volunteer hours can be accumulated by volunteering at a CDCTS sponsored events, including the upcoming Western Dressage Show, May 15-16, 2021, by helping set jumps, running score sheets, helping tear down after the show, etc. In lieu of volunteering at a CDCTS sponsored event, a Junior rider can write and submit to the monthly newsletter, an informative equine related article for the equivalent of 2 volunteer hours and/or a Junior rider can interview a professional in the equine industry, such as a farrier, veterinarian, trainer, etc, and submit the written interview to the monthly newsletter for the equivalent of 2 volunteer hours. Open riders can donate a lesson to a Junior or AA, in lieu of volunteering at a club sponsored event.
- The Board is pleased to offer a "Hors de Concours" class to the CDCTS Spring Schooling Show on May 29, 2021. Alece Ellis will draft a post to be put on the CDCTS Facebook page announcing this added class.

- Melissa Morehead has created a new FB page named East Tennessee Boarding and Training Options and invites club members to “Like” this page.
- Susan Hill brought up the possibility of a dressage only schooling show the second week of July at a new facility in Lenoir City. Additional details forthcoming.
- A request from Two Step Revolution was received for CDCTS donation consideration. Two Step Revolution (TSR) is a non-profit, charitable organization that offers combined Mental Health and Equine-Assisted Services to individuals in and around Knoxville, TN. TSR was founded in 2017 by a Licensed Mental Health Counselor and a professional horse and equestrian trainer as a self-funded outreach, with the mission of providing holistic, personalized, low-cost therapy to individuals with otherwise limited access to mental health service. Carolyn Ordal will reach out to gather information about the organization’s criteria for assistance. This is tabled at this time.

What is Western Dressage?

In the mid to late 1990's Eitan Beth-Halachmy and his Morgan stallion, Holiday Compadre, found the spotlight at many expos and demonstrations. The pair's own brand of horsemanship quickly became known as "CowboyDressage" as evidenced by the stallion's self-carriage and elegant style, which is attributed to Eitan's use of classical dressage principles in his training program.

From the example set by Holiday Compadre, Cowboy Dressage and Western Dressage were born. CDCTS has been offering Western Dressage (WD) classes at its schooling shows for several years. Several new CDCTS members will be riding Western Dressage (WD) tests at our schooling shows – so we thought we would give you a quick introduction to the sport.



The WD classes offered by CDCTS use the Western Dressage Association® of America (WDAA) tests. WDAA's focus is on education about and the promotion of Western Dressage. USEF has recognized WDAA as the sole affiliate representing the discipline of Western Dressage. The description of WD from USEF is as follows: Western Dressage integrates the historically validated principles of dressage with the best of Western stock horse tradition. It is a systematic and progressive system of training for the Western horse and rider in traditional stock tack with the purpose of enjoying a safe, pleasurable, versatile, and useful working horse. The hallmarks of the Western dressage horse are usefulness, rideability, willingness, safety, pure gaits, lightness, calmness, and steadiness. A Western dressage rider should be attentive and tactful. They should use clear, effective, subtle aids coupled with a confident seat and light, responsive hands in communication with their horse.

A Western dressage partnership should exhibit impulsion originating from deeply engaged hindquarters transmitted without resistance through a supple topline to a light, soft contact with the rider's hand(s). The horse should move freely forward, laterally, and to the rear via a willingness to work off the hindquarters, which enables the Western horse to be a useful working partner. A Western dressage partnership should culminate in a happy, harmonious horse and rider relationship.

Western dressage tests provide the opportunity for horse and rider to demonstrate growth through a series of progressive elements by advancing from test to test and level to level as they develop in physical skill, mental maturity, and partnership. Competitions are both rewarding and educational, with judges providing scores and offering feedback for each element, as well as for collective marks demonstrated throughout the test. Western Dressage invites all breeds (including gaited horses) to participate! This inclusiveness along with many entry levels offer opportunities for western style horses to compete and shine! All tests are ridden in a traditional dressage arena set-up. WD rules and tests may be found on the WDAA website, www.westerndressageassociation.org, or through USEF.

Alece Ellis holds judging cards for North American Western Dressage (NAWD), IJA (Senior Dressage and Rail), RMHA (Senior), MFTHBA and is a Provisional Technical Delegate for USA-WE (Working Equitation). In addition to currently serving as CDCTS Vice President, Alece also serves on the Welfare Committee of the American Horse Council and is Secretary/Treasurer for FOSH (Friends of Sound Horses, a 501c3 non-profit organization).


USING YOUR SEAT

Generally, ONE OF the first comments I have when I sit on a student's horse is "He's not listening to my seat." What does that mean?

It means that the rider isn't able to influence the horse using their seat and thighs. A well trained horse (at any level) should be able to be ridden entirely through seat aids with very little influence from the hands.

That means ALL lateral work, ALL collective work, ALL mediums and extensions, and ALL transitions (to include reinback) should originate in your seat. How do you do that?



You have to have total control of your body---that means being able to use each muscle in your body separately and ONLY when you need to to make a movement happen. If you have random body movement, then your horse has no way of interpreting what you mean him to do. You can have no stiffness throughout your body – only toned muscle strength and relaxation. You need to be able to use your thigh without tightening your lower leg or your wrist without involving your forearm or shoulder. Most important, your back must be strong but flexible to be able to perform varying degrees of half halts without engaging any other body parts. Your left side should be independent from the right side; your hands and arms independent from each other as well as from your legs.

In order to achieve this, you need to work on your own fitness, off the horse. Choose an activity you like: running, walking, swimming, biking, or something else. Plus, you need strengthening exercises – get your core very fit because that's where all the horse movements should originate from. You don't have to have a gym membership, BUT you do have to have a committed home exercise program daily.

One of the best ways to learn how to isolate and use individual body parts is to take yoga classes. Yoga strengthens and supple the whole body. Another thing you can do at home is to use an exercise ball for balance and strength – you can even trot and canter on it! Guaranteed it will help your lower back and seat be stronger and more flexible.

When you have control of your body and a strong core, your communication with your horse becomes a whisper and your time in the saddle will be a pleasure. Because you can maintain a soft contact, head tossing will become a thing of the past!




