# **From Your President**

Get ready, our fall schooling show is coming up and will be held September 25 at Walnut Grove Stables in Talbott, TN. Please note that the classes are like those for our July 10 show. We're offering classical, western and gaited dressage, two fun classes—egg in spoon and ride a buck—as well as two Working Equitation type obstacle classes. We were unable to secure a venue for September 25, where we could offer combined tests in addition to our dressage classes. CDCTS member Dene Masengill graciously offered her Walnut Grove Stables to host the show and we adapted to the location.

Valerie Cheatham, L Judge with distinction, is judging the dressage classes and the two fun classes. Maria and Arielle Blackstone who teach Working Equitation, have volunteered to judge the obstacle classes. We are very fortunate to have these three women for our September show! Closing date is September 15, so get those entries in!

Our show committee is already seeking sites for our Spring Schooling show, tentatively scheduled for May 7, 2022 and the Fall Schooling show on September 24. We do need an area/arena that will fit a large dressage arena, 60m x 20 m. That's about 198 feet long by 66 feet wide. There also has to be adequate parking, a warm up area and jumping area. If you have a suggestion of a host venue or want to volunteer your farm, please contact any of the CDCTS board members with the information.

We're getting into the last 3 months of the dressage year—our membership runs Dec 1-Nov 30—and there is plenty of time to get the required hours in to qualify for year-end awards. For the September 25 show, we need ring stewards, scribes, score sheet runners, parking attendants, set up help on Friday, September 24 and tear down help after the show on September 25. CDCTS will be running concessions at this show and two folks are needed for that. Please contact me if you wish to volunteer.

# TRAINING DAMASCUS BY JEAN SULLIVAN

When Dr. Melissa Hamilton first came out to check out Damascus and look at his face after he was born, she said something odd to me. "You know he's probably going to be hard to ride." I looked at her and asked "Why? Because of his nose?" "No, because he's a double whorl horse and they can be difficult!" I kind of let that go through one ear and out the other because I had enough to worry about just dealing with his breathing problems.

I usually start my babies in training from their first steps. This includes the basics of leading, standing, being tied, etc. By the time they are three they have been lunged without saddle or bridle and gradually taught to lunge with saddle, bridle, and side reins. Before riding a young horse I get up in the saddle two or three times while tied at every training session. This advances to getting up on the mounting block in the ring and then riding. Damascus had no trouble making good progress through the before mentioned steps except he was very mouthy and prone to argue as are most young stallions. The mouthiness was quickly progressing to chewing on the handler, usually me. A couple of years before this I broke his half brother as a stallion. So normal stallion behavior was not new to me.

Damascus was starting to progress beyond what I thought was usual and expected. He wasn't mean. He was just temperamental. His paddock had an outside fence with boards at the top. The boards were located on the outside of the fence due to the curve in the fence. If dinner was late or something else didn't suit his fancy, I would come outside and find at least one of those boards lying on the ground where he had hit it with his chest and knocked it off. I have come out and found all six of them lying on the ground after a particular lengthy tantrum. The first time I got on him to ride, I got on him in a stall. I did worry a bit about him plastering me against the ceiling, but he knew he was confined so he didn't buck or rear but I could tell he was very ticked off with the entire program. The first time I rode him in the ring my son led him by a rope tied to his halter while I had the reins. He proceeded to try to chew my son's arm and shoulder off going around the ring. It was time to call the vet and schedule his gelding procedure.

After waiting about two months for his testosterone level to drop, I started riding Damascus. This was about the time I began to remember the double whorl statement from Dr. Hamilton. According to the literature that I found on whorls on horses and their possible meaning, a double whorl that is located on a horses face above the line drawn across eye level means that the horse will be talented but could be hard to ride. Supposedly this is due to the horse being good at using both sides of his brain which the whorls indicated developed at the same time. Do I believe this? I wouldn't if I had never had Damascus.

Damascus has never bucked trying to throw me off or reared. He is very headstrong but also very subtle at getting his way. We progressed through training and first levels without too much difficulty. He didn't like to bring his head down to get on the bit, and everything he did had to be at top speed. His motto to get through a test was "Get Er Done!!!" He has big gaits and knows how to use them. Lengthening at trot and canter were the fun parts of a test. He did have some problems with decreasing speed at the end of a canter lengthening. Debbie Schwartz as a judge witnessed a test where we never decreased speed at the corner near where she was sitting. Luckily he was handy enough to handle the corner at full speed. She informed me after the show that I had to MAKE him slow down. Easier said than done.

We made it through second level without any big difficulties and had confidence that third level would go as well. Unfortunately I hadn't considered that flying leads would be the problem they turned out to be. Damascus' grandmother was exceptional at flying leads, and I was hoping that he had received this talent genetically from her. At sixteen years of age I was doing flying lead changes every other stride on her. I didn't think there was anything special about this. Unfortunately whatever genes it took evidently passed him by. We spent four years first learning what a flying lead was and then learning when and when not to do them.

# TRAINING DAMASCUS - CONTINUED

My horse is exceptionally talented at finding the easiest way to do a movement. Every movement he does has three steps involved. The first step involves learning and doing the movement correctly. This means the movement will get a decent score in a test. The second step is how to evade the movement. For example Damascus has fifty ways to do a turn on the haunches. Most of which are not likely to get a good score in a test. I believe this where his double whorl comes into play.

Jim Koford stopped me during a lesson to ask me a particular question. "Do you realize your horse tries to out maneuver every cue you give him?" "Thank God!" I told him. "Someone finally understands my horse!" The last step involved in my training a particular movement is figuring out how to make him do it correctly without him being able to modify it. Then that movement is ready to show!

Another factor that helped me get through third level was switching to a double bridle. I spent the previous levels trying to slow Damascus down and lower his head carriage. With a snaffle bit he was always leaning against the bit and my shoulders were always pulled forward. Half halts helped some but never totally ended in self carriage. The double bridle finally gave me the control I needed to make him listen. This didn't come quickly or easily but it did finally happen. I could sit back without having to brace and my shoulders relaxed. We worked all winter to lower his head carriage and get the push we needed from his rear end. I had to convince myself first that this type of head carriage wasn't affecting his breathing, and after spending months testing the new connection, realized that it didn't have any effect. I felt that I had a new horse.

I want to thank the people that helped me through the journey I have made with Damascus. Thank you Cathy Fox for starting us out right with the basics. Thank you Carol Grau for letting us train on your beautiful property. Thank you Rita Dunn for the encouragement in your ring and mine. I do a better half halt thanks to you. Thank you to Emily Broillier Curtis for encouraging us, and Jen Bolen for letting me use your fantastic ring. Thank you Jim Koford for making me try harder and for understanding my horse. Thank you Kim Clelland and Steve Lloyd for taking beautiful pictures of Damascus. Thank you CDCTS for holding the shows that gave me opportunity to try our wings. Thank you to the numerous people who gave me encouragement along the way.

This horse was a gift from God that took me a while to recognize. I have learned more from him than any other horse I have ever trained. He challenges me daily, and I find I am a much better rider and trainer due to this challenge. I hope anyone reading this will take away the message that in horses when something looks so bleak that it is hard to understand, it may be a gift in disguise.

# 5 Pieces of Advice From Tokyo's Dressage Medallists

# Tokyo 2020 Dressage stars give us the secrets of their success...

In celebration of all things Tokyo, we're rounding up the best advice from riders who earned themselves a much sought-after medal at these Games. After all, who better to listen to than people right at the top of their game?

In the Dressage edition, you'll find nuggets of wisdom from the likes of Tokyo 2020 double gold winner Jessica von Bredow-Werndl, Olympic icon Charlotte Dujardin, and American multiple medallist Steffen Peters.

Words to live by, we reckon.

# 1. If the horse isn't on the aids, the flying changes are doomed

There probably isn't a rider on the planet who hasn't struggled with changes at some point, or won't at some point in the future. Those pesky little skipping steps might look lovely and fluent, but they're often a big hurdle to overcome in a horse's training...and a rider's!



Often when you struggle with the changes, you'll find lots of exercises to help improve them. And while it's true that you need to have a well-balanced canter and your horse needs to be supple, there's one golden rule, according to Tokyo 2020 Team silver medallist Steffen Peters: "If the horse is not on the aids, you are in trouble."

While you might get away with a change which is a stride late on the aids at lower levels, you'll certainly never have reliable tempi changes. And if the horse isn't responsive to your leg aids, you're also far more likely to produce a change which is late behind rather than clean.

So be honest with yourself from the very start about whether your horse is truly on the aids. Does he respond to a lovely light touch for the canter aid from walk? Is he listening to your seat? Do you have to nudge him along every few strides in canter to keep him going? If so, be strict with yourself and your horse about expecting a clear and immediate response from your aids.

# 2. Quality over quantity

This is a piece of advice which can't really be attributed to only one Olympic medallist. Team bronze medallists Carl Hester and Charlotte Dujardin are perhaps the best-known proponents of days off, easy work for young horses, and "letting your horse be a horse."

But it's not a new concept. Even double gold medallist Jessica von Bredow-Werndl made it clear that she schools TSF Dalera in intervals too, allowing her a couple of days off after a few days of intense schooling or training. The German is a big believer in creating a happy athlete and giving them lots of experience by doing lots of hacking and galloping work with her horses.



Moral of the story? Quality over quantity.

It's better to have three days of excellent schooling with breaks, stretching, or hacks in between than it is to have six days of sour, mediocre schooling. If your horse does something well, give them a reward and a little break. Be free and easy with the praise, and don't keep "drilling" for the sake of it.

Horses, like humans, need variation. They simply can't be expected to give 110% day in, day out, for years.

# 3. There are many roads to Rome

So maybe that's not the exact quote that Dressage queen Isabell Werth – who won her 11th and 12th Olympic medals in Tokyo – used. But she's often said that finding the key for each horse is crucial to success.



As she put it during an interview, "there is no horse without some problem, without some ups and downs, and the goal is to find a key and not to give up – if this one doesn't work, we have to find another one. This is what I really love to do."

Where one horse might need to be ridden lower in the neck, another might need a containing outside rein, one might require lots of outside flexion to get them straight. Others might need to go quicker in the hind leg.

Essentially, though the basic principles remain the same, the actual methods you use might vary a little to suit a given horse. Just like

humans – we might all have to pass the same exams at school, but people learn the materials differently and excel in different areas.

# 4. Don't be afraid of the power

Of course, Charlotte Dujardin was always going to make an appearance on this list. In fact, the hardest part was choosing from her many pearls of wisdom. One of the other strong contenders was the iconic "short reins win gold medals."

But in the end, there's so much truth in this one small quote, and it ties in to so many other things Charlotte has said. In clinics, she's famously always telling riders to gallop and get the horse really forward and to be forward-thinking with the hand.

Essentially, you have to harness your horse's power rather than throttling it. Working with 500-kilogram animals means that you can't be scared of their power, but have to find a way to work with it to get the best out of your horse. This is especially true when you're wanting to ride upper levels and really get those bold extended paces and uphill gaits.

As the saying goes, stop riding with the handbrake on.

# 5. Be proactive

Sabine Schut-Kery was one of the most memorable performers in Tokyo, and was responsible in part for Team

USA's silver medal in the Dressage.

Although Schut-Kery is less prolific than the likes of Werth and Dujardin, her clinics have often focused on being proactive.

What exactly does that mean? Set expectations and communicate them clearly to your horse. Don't wait for your horse to spook and then get flustered and correct it – instead, put your leg on in the corners to pre-empt any theatrics.

If you feel your horse stall a bit in the hind end, correct it immediately before it becomes a "big deal" or a larger correction. Set your horse up well in the corners. Properly prepare for movements rather than thinking about them as



you're meant to be starting the half pass, pirouette, transition, or whatever it is you're wanting to ride.

Basically, bring as much to the table as your horse does!

**Entries**: All entries MUST include a copy of a current negative Coggins. The CDCTS/Walnut Grove Stables release form must be filled out, signed and dated by rider and/or parent or guardian if rider is younger than 18 years old. Stallions are permitted to show at Walnut Grove Stables.

Payment in full must accompany the entry form. If payment has not been received by closing date of Friday, September 17, 2021, the entry will be charged the late fee of \$15.00. **Awards**: Ribbons will be awarded in all classes for placements 1st through 6th place. Depending on class size, Open and Adult Amateur divisions may be pinned together. Junior division will be pinned separately. High Score Adult, High Score Junior and High Point Western/Gaited dressage will be awarded for dressage classes only.

**Arena**: All Dressage Tests will be ridden in the arena. Footing is sand. Warm up area will be in the lower arena.

Dressage tests Intro, A, B, C, Western Dressage and Gaited Dressage tests will be ridden in a 20 m x 40 m arena. All other dressage tests will be ridden in a 20 m x 60 m arena.

**Obstacle classes:** Obstacle classes will be ridden in the large arena. These obstacles will be similar to those found in Working Equitation. Obstacles will include clover leaf barrels, slalom poles, ground poles for side passing, x-rails, bell corridor for backing, and gate. The judging will be consistent with that of a dressage test, with respect to proper bend, square halt, horse immobility, symmetrical geometry, willingness and tempo of horse, harmony between horse and rider, as well as completion of the course without error. A course map is being provided and will also be available at the show.

**Attire:** Appropriate informal schooling attire is required. **No tank tops or t-shirts allowed.** ASTM-SEI approved helmets and appropriate footwear is required and must be worn at all times when mounted.

**Parking:**Cars may be parked separately from trailers, depending on numbers. Trailers will be parked in an assigned area. Please follow signs for parking and **park only in designated areas**.

**Ride Times**: Official ride times will be posted on the CDCTS website and Facebook page(s) by Thursday September 23, 2021 9 pm.





River Glen Equestrian Park – 1834 London Rd, New Market, TN 37820.

Class 1: Walkers—Teams of 2-5 riders who want to walk (and maybe a little trot) while they enjoy a ride around River Glen Equestrian Park. This group's teams will start at 3 minute intervals, starting at 9:00 a.m. The last team should be on course by 10:30 a.m. If more than 20 teams sign up for this Group, all other times will be adjusted accordingly. There will be a mandatory stop on course. Team closest to optimum time wins.

Class 2: Hilltoppers—Teams of 2-5 riders who want to walk, trot and do some cantering around the course at River Glen Equestrian Park. This group's teams will start at 5 minute intervals, starting at 11:00 a.m. There will be a mandatory stop on course. Team closest to optimum time wins.

Class 3: Fast 'n Furious—Really just sort of fast, and hopefully having a good time, so they are not "furious". Teams of 2-5 riders who elect to travel the course at a USEA Novice level eventer's pace. This group's teams will start at 3 minute intervals beginning at 1 p.m. Team closest to optimum time wins.

Class 4: Jump class For those who want to *soar* (maybe not *soar*, this is not summer Olympics!!!) over jumps—maximum height is no more than 2'3". Jump course starts at 2:15 p.m. Individual entries or no more than 3 on a team. Individual or Team closest to optimum time wins. Jump class will start after last Class 3 team has finished. We are only using the starter novice jumps at River Glen.

**Class 5: Costumes!** There will be no separate costume class, but anyone in any group can ride in costume to qualify for a ribbon in this class. Awards in both Adult and Kids Under age 16 categories.

Class 6: Run for the Money! Do you feel *Lucky*? Each team will be dealt 5 cards for a 5 card stud poker hand. At some point on the course, the team will have the option to trade in up to 3 cards for new ones. The team with the best hand wins! Along with a ribbon, First place team gets the entry fee for this class (\$15) back, 2<sup>nd</sup> place team gets a ribbon \$10 back and 3<sup>rd</sup> place team gets a ribbon \$5 back. The 4-6<sup>th</sup> place finishers just get pretty ribbons.

Class 7: Wine/Whine by the Barrel! This is for teams of 2. Rider A starts at 1 end of the area, rides to the barrel in the middle and drinks a glass of wine (or lemonade), then proceeds to the opposite end of the arena. Rider A must hand tag Rider B who repeats riding to the barrel, drinking the wine (or lemonade) and crosses the start/finish line. Fastest Team wins! A special prize awaits the winning team! Must show valid ID in order to have wine by the barrel. Otherwise, you can just whine about it. This class will start after the last jumper has completed the course.

**Rules:** Each class (1-4) will have a predetermined optimum time and winners are based on closest to optimum time. Penalty points assigned for missed jumps and/or refusals in Class 4.

Entries: Entries accepted via mail or Paypal and will close Oct 26, 2021 at 6 p.m. Include a current negative Coggins with your entry. If already registered by closing date, you can add classes day of show—bring cash or check for day of show additions.

Fees: Class 1-4 fee is \$15 for CDCTS members; \$25 for non members. Fees must be paid prior to class. Class 5, 6 & 7 are \$15 each for everybody. There is also a \$10 per rider fee for River Glen. A \$2 Paypal fee will be charged if paying that way.

Tack: English or Western Tack may be used. Helmets and appropriate footwear must be worn at all times while mounted.

#### **SAFETY FIRST:**

- 1. All riders must wear helmets at all times when mounted.


