(WWOA) is pleased to offer a "Train-the-Trainer" program for operators. The course is designed for those

interested in becoming an instructor in their field of operations, or for experienced trainers who are looking to improve their skills.

This valuable opportunity will be made available for up to 24 operators, and will be FREE for those who are selected. The class will be held in the Fall of 2025.

Once the training is complete, WWOA will support this group of instructors in developing specific coursework and then delivering the training at a WWOA-sponsored event.

WWOA knows that there is a serious need for qualified operator instructors in every discipline, and every water/wastewater system. Our goal is to help develop the next generation of instructors with skills to build effective training courses, and confidence to deliver them.

WWOA will accept applications through July 31, 2025. Final selection will be based on the following:

- The individual's area of expertise (water treatment, collection systems, etc.)
- Years of experience in the trade
- Experience in providing training
- Your Bio/Resume
- Letter of Recommendation

Expectations:

WWOA Membership: Applicants must be, or will become a member of WWOA, and continue that membership through the period of this agreement.

Session Attendance: Applicants must attend all sessions (three ½-day virtual, one in-person, final session late fall). The cost of these sessions is covered in full, by WWOA, and we want to be sure that the limited seats available stay filled.

Selected participants must commit to:

- Attending all sessions (three ½-day virtual, one in-person, final session, late fall)
- Developing a minimum of seven (7) hours of training.
 This can be two sessions that are 3.5 hours each; or one session that is seven hours.
- Deliver the course at a WWOA-sponsored event

Course Development: All applicants are

expected to develop a minimum of seven (7) hours of training. This can be two sessions that are 3.5 hours each; or one session that is seven hours. The deadline to complete is 6 – 12 months after the final workshop, and will be compensated at \$750 for developing 7 hours of training, either in one single class, or 2 discreet 3.5-hour classes.

WWOA will participate in determining class topics to be sure that a diverse catalog is developed. **The class must be approved by Maryland and Delaware licensing boards as appropriate**, and WWOA will complete these applications as the Sponsor. Payment for content development will be made in one installment when the course is approved for operator credits.

After development, WWOA will be the sole owner of the class content, including slide decks, handouts, and tests. Instructors who successfully develop the materials will be permitted to deliver the content outside of WWOA as long as the instructor does not receive compensation for doing so.

WWOA is committed to supporting participants in developing materials, but we expect that those selected for the program will be able to research and produce most of the content.



Couse Delivery: Once the course is developed and approved, instructors agree to deliver the content at a future WWOA training event, within 2 years of completing the Instructor Training workshop. Opportunities include a Section Training offered throughout the year, the Tri-Association Conference, or at the instructor's discretion.

About the Program:

WWOA has established a contract with A. Kelly & Associates to deliver this Trainer Development program. The firm brings specialized expertise in Train the Trainer, Leadership Development, Communications, Strategic Thinking, Goal Setting, Customer Service and Presentation Skills.

The program will include three half-day virtual segments, to meet the operators' busy schedule. The sessions will be facilitated from September - November 2025, with a final session in-person, in Annapolis, MD.

For this effort, WWOA will establish a "cohort" or class of operators and industry professionals who are interested in providing training and assistance to the water and waste operators in Maryland, Delaware, and the District of Columbia.

The size of the group will be dependent on applications received, but will be capped at 24 individuals.

How to Apply:

Enclosed is an application that individuals must complete and **submit by 5:00 pm, July 31, 2025 in order to be eligible** – NO EXCEPTIONS, no late submissions will be accepted.
