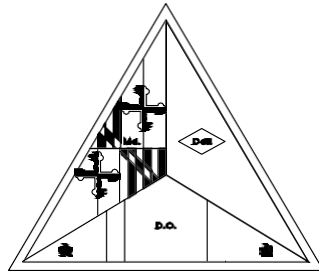

To become NEW member **online**, follow these steps:

1. Visit www.wwoa.net
2. Click on "JOIN" on the upper right, or in the middle of the Home Page.
3. Complete the online member application, submit and proceed to payment.
4. You will be required to pay by credit card or debit card - you will not be invoiced – you will receive an automatic receipt when your transaction is complete.
5. We will email your membership confirmation.

To RENEW your membership **online**, follow these steps:

1. Visit www.wwoa.net
2. Click on "LOGIN" on the upper right, or in middle of Home Page.
3. Select "Current Members" to login.
4. If you have accessed your online account with WWOA, you have created a unique password. If this is your first time accessing your WWOA account, use your Member Number as your ID, and **WWOA** as your temporary password (or contact info@wwoa.net for assistance)
5. You will be required to pay by credit card or debit card - you will not be invoiced – you will receive an automatic receipt when your transaction is complete.
6. We will email your membership confirmation.
