Agreement for custom tiny home construction





1. Parties

2. Project Specifications

Builder agrees to construct for Buyer a custom tiny home ("Tiny Home") according to the following specifications:

Detailed plans and specifications are attached as Exhibit A and incorporated into this Contract by reference. Any changes to the specifications after the date of this Contract must be agreed to in writing by both parties.

3. Price and Payment Terms

The total price for the Tiny Home is \$[TOTAL PRICE]. The payment schedule is as follows:

4. Timeline

Builder is not liable for delays caused by factors outside of their control, including but not limited to weather, material shortages, or permitting delays.

5. NOAH Certification (Optional)

If the Tiny Home is to be certified by NOAH (National Organization of Alternative Housing), the cost of certification is [COST] and is the responsibility of the [BUYER/BUILDER]. Builder agrees to build the Tiny Home to meet NOAH standards. Documentation of NOAH certification will be provided to Buyer upon completion.

6. Warranties

Builder warrants that the Tiny Home will be free from defects in materials and workmanship for a period of [NUMBER] years from the date of delivery. This warranty does not cover damage caused by misuse, neglect, or acts of God. Specific warranty details are provided in the attached warranty document (Exhibit C). All appliance warranties are managed through the appliance manufacturer.

7. Delivery and Acceptance

Builder will deliver the Tiny Home to [DELIVERY LOCATION]. Buyer will inspect the Tiny Home upon delivery and will notify Builder of any defects or discrepancies within [NUMBER] days. If Buyer fails to notify Builder of any defects within this timeframe, the Tiny Home will be deemed accepted.

8. Governing Law

This Contract shall be governed by and construed in accordance with the laws of [STATE].

This Contract constitutes the entire agreement between the parties and supersedes all prior or contemporaneous communications and proposals, whether oral or written, relating to the subject matter hereof.
