

General conditions of bike hire

- ARTICLE I. The service organization Bikerent-Silvercoast («the owner»), charged with renting out bicycles, has the right to examine the capacities and fitness of participants to ride a bicycle in the framework of Bikerent-Silvercoast services. The person renting the bicycle (hereafter referred to as «the tenant»), declares to be fit for using a bicycle and not to suffer from any medical counter indication.
- ARTICLE II. The rented material (bicycle and accessories) remains the full property of Bikerent-Silvercoast during the entire period of rent. The tenant cannot lend or sublet the material to a third party without the consent of Bikerent-Silvercoast.
- ARTICLE III. The tenant declares that the bicycle is in perfect working order, and commits him/herself to use it with proper care, to see after its maintenance, and to return it after the period of rent, in the same condition as (s)he received it, and to return it to the owner at the date and venue stipulated in the contract. Any delay will be indicated to the owner. The tenant knows the condition, size, and model of the bicycle. Before leaving, the tenant has the right to try the bicycle. If it does not seem to correspond to the expectations, (s)he can ask for replacement. After departure, the tenant has accepted the bicycle in its current state.
- ARTICLE IV. Bikerent-Silvercoast has the right to recover the damages caused to the bike during the period of rent by invoice, the tenant hereby agrees to this arrangement.
- ARTICLE V. If a bike turns inoperative during the period of rent, the tenant is responsible for returning the bicycle to the agreed location. Wherever possible, the owner tries to solve the problem. If something like this happens, contact the owner as soon as possible. The tenant can only do repairs or have repairs carried out after approval from Bikerent-Silvercoast and must hand over an invoice of the repair. The tenant can under no circumstances claim damages or interest for usage problems during the rental period.
- ARTICLE VI. Bikerent-Silvercoast is not responsible for personal accidents, damage to property, material damage caused by third parties or other factors outside the fault of Bikerent-Silvercoast. The tenant is requested to sign a rental agreement and a safeguard clause at the start of the rental period. By signing this safeguard clause, Bikerent-Silvercoast is protected from claims in this regard.
- ARTICLE VII. In case the bike is stolen, we will charge you the replacement value of the bicycle minus the rent due to the replacement of the stolen bicycle.
- ARTICLE VIII. The tenant is obliged to take good care of the bicycles and to take all necessary precautions to protect the bicycle (s) against damage, loss or theft. In one of the above situations, the costs of repair or replacement are at the expense of the tenant.
- ARTICLE IX. If the bike is returned dirty, Bikerent-Silvercoast reserves the right to charge a compensation of 15€.
Rates for damaged parts (classic bike): saddle € 20, rear wheel lock € 31 and/or key € 15, lighting set € 20, chain guard € 21, fork € 50, luggage rack € 30, bell € 5, derailleur € 20, standard € 13, mudguard € 11, complete rear wheel € 80, complete front wheel € 75, worn tire by skidding € 40, gear system € 150. Rates for damaged

parts (electric bicycle): saddle € 20, pedals € 20, standard € 17, chain guard € 22.50, derailleur € 58, fork € 75, complete front wheel € 80, full rear wheel € 95, front light € 21.50, rear light € 13, luggage rack € 70, fender € 30, rear wheel lock € 31, Force curl lock € 20, front or rear disc brakes € 55, Bosch battery € 600, charger € 172, display € 110 and holder € 13, shifter € 40 Rates for damaged parts (mountain bike): saddle 39 €, stem 75 €, front wheel 120 €, rear wheel 155 €, shifters 40 €, pedals 16 €, SPD pedals 30 €, SPD-SL pedals 40 €, Look pedals 40 €, rear wheel lock € 30, brake levers € 50, disc brake € 30. Rates for damaged accessories (others): helmet for adults € 30, children's helmet € 25, bicycle bag € 35.

The rates for damaged parts that have not been listed will be determined by Bikerent-Silvercoast. The wage for repairs is € 49 / hour.

- ARTICLE X. If the tenant contravenes any law or regulation during the period of rent, Bikerent-Silvercoast can in no case be held responsible. Cyclists ride on their own responsibility and abide by traffic regulations.
- ARTICLE XI. Rental cost of bicycles and accessories must be paid beforehand. The hirer must hand over an identity card. Bikerent-Silvercoast reserves the right to request an additional deposit of 150 € per hired standard bicycle (Trekking/MTB/Road) and a deposit of 300 € per hired electric bicycle. The deposit will be returned to the hirer once the bicycles and accessories have been inspected.
- ARTICLE XII, By signing the lease agreement, the tenant declares to be aware of how he / she should handle the bike and how to keep the bike in good condition. The tenant also agrees with the Bikerent-Silvercoast Bicycle Rental Terms and Conditions.
