

Program Regulations and Progression Rules for Professional Diploma In English language & Liberal Arts:

To successfully complete the Advanced Diploma in International Criminal Law and Criminology, students must fulfill the following program regulations and progression rules:

- 1. **Duration:** The program is designed to be completed within 6 months, with each module lasting for the instructor prescribed period. It is important to adhere to the timeline and complete the modules within the specified duration.
- 2. **Module Completion:** Students are required to complete all six modules of the program successfully. Each module covers specific topics related to English Language Proficiency, English Literature and Criticism, Introduction to Liberal Arts, Social Sciences and Humanities, and Research and Applied Liberal Arts.
