ENROLLMENT FEES:

This figure is the total Annual Payment. If you wish to pay a monthly amount, then take the total and divide by 12, then round up to the nearest cent (for example \$2,110 + \$300 levy = \$2410 divided by 12 = \$200.8333333, then rounded up to \$200.84/month).

Commencing Part way through the Year?

Students enrolling in Year 1 – 9 may enrol part way through the year and still pay only 1/12 the annual fee per month.

For Year 10-12 Award Students, the total fee remains the same for a whole year, part year, or Recognition of Prior Learning (RPL).
