- Ted following up to raise homeowners dues based on inflation. Possibly increase to \$360 a year or \$30 a month. If not, we will continue in a deficit.

- Distributing the spring flyers to all homeowners.

# New Business to Move Forward – Assigned Task/Review

- Treasury report March we were at \$24,081.08 total expenditure. April expected balance \$24,078 and by end of May \$21,849 projected.
- Alisha and Karrlie will renegotiate landscaping contracts with Bobbie and Jose.
- Ted will reach out to Milton Public Works regarding the \$3,900 yearly cost that we pay for the electricity for street lights. Maybe Milton will be required to pay since we are now incorporated within their city limits.
- Ted brought up reducing our budget for treats. We only provide during our annual homeowners meeting so we can reduce that expenditure considerably.
- Concern brought up about the first home when entering our neighborhood off of 380<sup>th.</sup> and the
  cutting down trees in the greenbelt. We will address when attending upcoming Milton town
  meeting.
- Alisha will review playground equipment for toddlers and provide proposal to board.
- Next Milton town meeting on May 6<sup>th</sup>. Board will all try to attend to address the street light expenses and the home that is cutting down trees in the greenbelt.
- Annual homeowners meeting including barbeque for all homeowners will be held at the park on June 22<sup>nd</sup> at noon.
