# **New Fundraising Ideas**

The Fundraising Committee is pursuing a brand new as well as a tried and true event to enhance the Civic Club's ability to raise money to give back to local nonprofits.

Fundraising Co-chairs Judi Merriman and BJ Gallagher are organizing a fashion show, Runway for a Cause . . . Fun, Food, Fashion . . . and Style! Chico's Morgantown has agreed to provide the latest fashions. Vanity Station Salon has agreed to help models with their hair. Models are needed by our club. Please consider volunteering.

Approximately eight models will walk the runway to show off the newest spring and summer fashions in three turns each, for a total of 24 different outfits. The clothes will be for sale at the show or may be ordered and picked up at Chico's Morgantown location.

A 10% discount will be given for any items purchased or ordered during the event. The exact date and the venue are still to be determined but the show will take place in May 2026. The cost will be \$45, which will include heavy hors d'oeuvres, such as little sandwiches, cheeses, dips, veggies and fruit trays, and sweets. Non-Alcoholic beverages are included, and wine will be available for purchase.

In addition to the fashion show itself, attendees will have the opportunity to bid on several donated, themed baskets. Twenty dollars will purchase 15 tickets and during the breaks when models are changing, tickets will be drawn, and the Winners can choose whatever baskets they like.

About 10 years ago we created a discount card with the help of a vendor company. On the card were about 12-14 area businesses including restaurants that either gave a discount or a free item. Some of the vendors were national companies which would be good to use at any of their locations.

We sold 250 discount cards for the price of \$20 and made a profit of about \$2,200. Each member of the club bought or sold two discount cards, and we sold the rest to the rental companies to share with their clients. It was a successful fundraiser which required little effort. So, we decided to try the cards again. We hope to have the cards ready by the kickoff spring selling season at our Anything Goes Flea Market.

Preview Night attracted 120 attendees who enjoyed complimentary beverages, light refreshments, live music, and a ticket for a door prize drawing. The drawing was a complete BBQ setup donated by Lowe's, which was won by local resident, Susie Sincell. Additionally, we conducted a 50/50 raffle, with club member

Terri Peterson winning and generously donating her winnings back to the club. Public feedback on the event was highly favorable, although vendor responses were mixed, with many reporting modest booth sales.

Appraiser Tom Dolan examined several items and noted the impressive quality and uniqueness of those brought by attendees. He looked at a wide range of treasures from a Shirley Temple doll to baskets, clocks and watches, and an FDR campaign cloth.

Pierogis and Kielbasa were once again a bit of a hit in the café. We ran out of pierogis just after lunch on Saturday. Traditional offerings of beef vegetable and matzo ball soup, sloppy joes and Flo Royer's egg salad were popular as were the baked goods.

A debrief session was held to evaluate this year's successes and areas for improvement, and planning for next year's event will commence shortly. We encouraged suggestions from all participants and stakeholders.

Terri Peterson has worked closely with me throughout the summer to learn the intricacies of organizing the event and will serve as the lead coordinator for next year. She, together with the raffle, sponsor, table, and café coordinators, will work to deliver another outstanding experience for visitors and vendors. As always, this event will require significant volunteer support. Terri shared, "I would like to thank all who volunteered for this event, in so many ways! We can't do this without you! As a newbie to the group, I'd also like to express my appreciation for welcoming me, tutoring me and guiding me along with this venture. # **Our Strategies for Selling Raffle Tickets**

Volunteer enthusiasm was one of the strategies which resulted in the best year ever in selling raffle tickets. Thanks to all the volunteers, the Club was able to make more than \$5,000 dollars in raffle sales this year, making 2025 the most successful year ever in raffle fundraising. That's \$1,500 more than 2024.

"It certainly helps us to have wonderful prizes. The quilt, the gift basket and the \$500 cash definitely gets people's attention," stated Jeannie Campbell, who leads raffle sales.

Key to our success in selling raffle tickets is dedicated volunteers who are enthusiastic and willing to engage with people they don't know. "Confidence and clarity help sway people to buy a raffle ticket," Campbell said. "Selling raffle tickets effectively takes a mix of strategy, enthusiasm, and good communication."

It helps that the Civic Club has a sterling reputation in the area. "Local residents know the power of the Civic Club, and all that we do to support the local community," she said. "We tell everyone who buys a ticket that every dollar we earn we give back to Garrett County residents."

Jackie Stein has several helpful tips in selling raffle tickets. "First, believe in what you're doing. If you don't want to sell tickets, do something else. It will show." Second, Jackie said, "Smile a LOT!" She also suggested having a 30-second spiel memorized so you can get it out quickly, for instance, "There are three prizes, including \$500 cash." That always gets their interest. And finally, "when they buy,

thank them and let them know that they're helping us to help non-profits in Garrett County."

It helps us have great prizes that people really want to win. When people see the quilt in particular, they get interested. What persuades people to purchase tickets even more is the Civic Club brand. "People know the work of the Club and our efforts to support the community. They want to help others," Campbell said.

Mike Tumbarello has helped sell raffle tickets for many years during the Antiques & Artisans Market and said his secret is to engage everyone with eye contact and welcome them. "Engaging people one on one, building a relationship and making a connection, really is the secret sauce."

Laurie Grant knows the power of saying "welcome" and "thank you" to everyone who passes by the raffle table. She was incredibly successful in selling raffle tickets at the Antiques & Artisans Market. Her strategy was to offer everyone who passed by the ticket table the opportunity to buy three raffle tickets for \$10 instead of offering raffle tickets one at a time at \$5 each." Her bundling strategy of first telling people that they could buy three tickets for \$10 resulted in huge ticket sales while Laurie staffed the raffle table.

Over the summer, Louise Carmichael had success with a different tactic. She brought her grandson, Wyatt, to the Oakland Farmers Market and had him wave the stop sign (made by Bob Simpson) and that really got people's attention. It's hard to say no to a cute kid.

Selling raffle tickets is a great way to introduce new members to the Club. Raffle sales are most often done with two members and is a fun and productive way to spend a couple of hours.

<u>This Tender Land</u> by William Kent Krueger - Story about four orphans who travel the Mississippi River during the Great Depression.

<u>The Light Pirate</u> by Lily Brooks-Dalton - Set in the future in Florida, a story of survival resilience.

<u>The Indigo Girl</u> by Natasha Boyd - A story of a sixteen-year-old girl in Colonial South Carolina, her ambition, betrayal, and sacrifice.

<u>Take My Hand</u> by Dolen Perkins Valdez - Inspired from true events, a Black Nurse in post segregation Alabama who blows the whistle on an injustice to her patients.

<u>How to Read a Book</u> by Monica Wood - Story about an English Teacher and a life changing power of sharing stories.

### What does GFWC mean?

GFWC stands for the General Federation of Women's Clubs. It is an international women's organization dedicated to community improvement by enhancing the lives of others through volunteer service. With more than 60,000 members in affiliated clubs in all 50 states, the District of Columbia, and more than a dozen countries, GFWC members work in their communities to support the arts, preserve natural resources, advance education, promote healthy lifestyles, and encourage civic involvement.

Founded in 1890, GFWC's roots can be traced back to 1868 when Jane Cunningham Croly, a professional journalist, attempted to attend a dinner at an allmale press club honoring British novelist Charles Dickens. Croly was denied admittance based upon her gender, and in response, formed a woman's club—Sorosis. In celebration of Sorosis' 21st anniversary in 1889, Jane Croly invited women's clubs throughout the United States to pursue the cause of federation by attending a convention in New York City. On April 24, 1890, 63 clubs officially formed the General Federation of Women's Clubs by ratifying the GFWC constitution. Since 1890, GFWC has been active throughout communities across the US and in 15 countries: Aruba, Austria, Bahamas, Belize, Brazil, Canada, Curacao, Cyprus, Korea, Netherlands Antilles, Peru, Philippines, Taiwan, Uganda, and Ukraine.

The Civic Club of Oakland came into existence in 1911 and joined the GFWC in 1913. Our club is part of the GFWC Southeastern Region, which includes: the District of Columbia, Kentucky, Maryland, North Carolina, Tennessee, Virginia, and West Virginia.

The Civic Club of Oakland has been part of the GFWC for 112 years and has been working for our community for 114 years! Our club continues to grow and prosper. Thank you, ladies!
