Standing Orders Statement read out by Cllr Mike Harvey at 19 May 2022 meeting

- I asked that this subject go on our agenda as soon as we meet following the appalling conduct at the last meeting of the previous Council in April 2022.
- Don't take my word for it. A member of the public, who came by accident and stayed for most of the meeting has told many friends and neighbours how unwelcome she felt and how awful it was (I have the name and address).
- There was zero following of standing orders and orderly debate. On one subject of discussion one councillor spoke 9 times. N.B. Standing Orders (SO) say once and with the Chairman's approval, once more.
 - 4 times the words "I'm getting annoyed by this" and "I'm angry over this" was said. This is a bullying tactic and is grounds for exclusion from the meeting. There was butting in and shouting down (raised voices).
- Can I immediately say that in no way do I blame the Chairman, who has never been shown how to conduct a meeting according to SO since joining the Council in 2016.
- So I am determined to return this Council to conducting business according to the rules of normal debate for Community Councils (and VoG).
- On the subject of rules, I want to remind Councillors we are a Statutory Body set up under the Local Government Act 1972:

constitution and powers of functions financial administration duties public notices burial responsibilities, etc.

There are subsequent Regulations, e.g. Acceptance of Office order issued by WAG 2004 – 1508 governing the conduct of today's events.

• I hope I've said enough to ensure that henceforth this Council behaves in a (civilised) lawful and orderly way.
