Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2022-23 was £8.82 per elector.





## Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2023 of **Wenvoe Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

### **Audit opinion: Qualified**

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

### **Basis of Qualification**

#### **Accounting Statement**

In my opinion, the Accounting Statement does not properly/fairly present the Council's receipts and payments/income and expenditure and financial position:

- The submitted and approved annual return was arithmetically incorrect and was not prepared on the correct basis. The Clerk subsequently resubmitted the annual return with the following amendments however the reported figures are net of VAT. I am unaware of these amended accounts being presented to the Council:
- The above figures are arithmetically correct however are still misstated given that the accounts have not been prepared on the correct basis.
- The Council was also unable to give a reasonable explanation as to why there are significant variances between the two financial years.

### Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

- Assertion 1 preparation and approval of accounting statements. The Council did not prepare the annual return in the form stipulated by the auditor, nor was the annual return arithmetically correct.
- Assertion 3 noncompliance with laws, regulations and codes of practice. The Council has not provided evidence that a budget has been approved by the full Council. The Council's budget which informs the precept must be approved by the Full Council.

- Assertion 3 noncompliance with laws. The Council has not provided evidence that it has
- Assertion 4 exercise of electors' rights. The Council approved the annual return after the commencement date for the exercise of electors' rights additionally no notice was issued regarding the Council and the Responsible Financial Officer certifying the return late. The Council should approve the annual return prior to the commencement of the inspection period and in accordance with statutory deadlines.
- Assertion 8 response to audit recommendations. The Council was unable to demonstrate it has responded to all recommendations and findings of the 2021-22 audit.

### **Other matters and recommendations**

#### **Members allowances**

It is recommended that the Council formally confirm on an annual basis which allowances it intends to pay. Those members who wish not to receive the allowance must decide on an individual basis and provide written notice to the Council's clerk. The schedule of allowances submitted to the independent remuneration panel should be published.

#### **Trust Fund Assurance**

The Council's internal auditor has marked that the Council has met its responsibilities as a trustee which is inconsistent with what was reported within the Annual Governance Statement. Nothing has come to our attention to suggest that the Council is a trustee of any charity and therefore recommend that the Council ensures that the Annual Governance Statement is consistent with the internal audit report.


