8. Other projects and responsibilities:

- a. WRAC Cllr P Freeman pointed out that Oaklands and Park Dyffryn Solar farms now had planning approval. In regard to implementation of a Community Plan, there had been 6 volunteers to date interested to help.
- b. Outbuildings Cllr S Milliner had finalised and provided the Clerk with the Licence Agreement. One Licence Agreement had been signed and returned.
- c. Guttering Fascia Boards the Clerk had contacted several local companies plus advertised on mybuilder.com and checkatrade.com with only one quotation being received to date re painting of fascia boards to Wenvoe Community Centre and outbuildings. Following discussion Council uanimously agreed to place the order with the Company that had provided the Quotation for the necessary remedial works to be carried out as soon as possible to prevent any further deterioration and to ensure that the project was completed before the autumn.
- d. Registration of land ongoing.
- e. Footpath & Conifer Hedge ongoing.

- f. War Memorial Cllr R Jervis informed Council that Armstrong Masonry had begun the restoration works.
- g. Cemetery Advisory Group Cllr P Freeman informed Council of the progress made in relation to the new proposed Cemetery site. Cllr M Harvey proposed Council to proceed with:
 - Council to resolve to specify the detailed scheme for a cemetery and car park
 - To identify procedure to acquire the land
 - To establish the grant regime and costs involved
 - To prepare a planning application with advice from the Vale of Glamorgan Council Cllr J Williams seconded, with Council unanimously agreed to proceed.
- h. Parking at Quarryman's Stone Cllr P Freeman is currently in contact with Cemex and will make enquiries as to whether the installation of large stones is feasible which would prevent the grass verge being used as a parking place.
- Bench & Stile St Andrew's Cross this item had previously been discussed at a previous Council meeting. It was noted that Wenvoe Community Council are not responsible for the overgrowth on this land.

11. To receive reports from Chairman, Clerk & Members:

- a. Cllr C Thomas reported that a member of the public had requested that the metal carabiners used for the Flagpole be changed to plastic due to the constant noise of them hitting the flagpole.
- b. Cllr R Sexton reported that there was a cable exposing numerous wires protruding from the ground near the entrance to the playing field at Twyn yr Odyn which was a trip hazard. Cllr R Sexton to provide Clerk with photographs of the cable to enable it to be reported to the Electricity Board and/or British Telecom.
- c. Cllr S Milliner reported that the village was littered with rubbish and that the bins within the village were overflowing. Cllr R Godfrey advised that the bins were regularly emptied and that he would make enquiries in relation to the possible placement of signage in relation to the usage of the bins.
- d. Cllr M Harvey reported that the kerbstones sited to the top area of Tarrws Lane were a potential hazard to motorists and the removal would improve the area. Cllrs to visit site and report to the Clerk.
- e. Clerk reported that all documents had been forwarded to Audit Wales for the year 2023 2024.
