We will make and try with customers to keep to scheduled appointments and use mobile phone technology over physical touching of doorbells etc. If it secure to do so we recommend customers bring/leave their bike outside the access point to the house and this is where we will return bikes to.

PPE

We will handle the bike wearing gloves and disinfect the bike and operate with gloves at all times. Our tools, workshop and hands will be regularly washed and disinfected to reduce the risk as far as possible and we will work to social distancing recommendations and where practical.

- 5. Quotes are based around our Price Menu found on the website.
- 6. Quotes are written or verbal and is an opinion that is open to error and therefore our advice does not construe acceptance of liability for any inaccuracies.

- 7. We will advise whether work is urgent and gain approval for any work to be carried out. We will also advise of any items likely to need to be replaced within the next year.
- 8. All work undertaken is insured.
- 9. All prices are in Pound Sterling (£) and subject to VAT.

2. For Service and Repair work the Customer agrees:

- 1. That they are the owner of any mobility product to be worked on or have authority from the owner to ask Active Bike Co Ltd to service or repair it.

- 6. Late payments will incur an 8% above the bank of England's base rate, together with compensation at the rate of £40 per invoice.
- 7. That any items left with Active Bike Co Ltd for more than 28 days after the invoice are assumed to be abandoned and Active Bike Co Ltd will take steps to dispose of the item. Storage of said item will incur a further storage charge of £20 per day until disposal.
- 8. That specifically requested parts, if not required will be charged at full retail price unless subject to the supplier returns policy they can be returned and refunded. Any costs to return will be paid by the customer.
- 9. Active Bike Co Ltd are not liable for items that don't arrive on time or out of stock items that show in stock at the time of ordering.

3. For good supply services the customer agrees:
