I attempted to make contact with Glenn Hunter, who was in the locked clubhouse (curtains drawn), but no one would answer the door. I attempted contact by phone and it went to voicemail. I informed the people outside that i could not force entry into the locked building and they will have to seek legal remedies through an attorney.
